Dear Mr. Soura,

Each year the Federation of Families for Children's Mental Health of South Carolina organizes a rally at the Capitol on National Children's Mental Health Awareness Day. This event is supported by the directors and staff of the child serving agencies and organizations of the SC Joint Council on Children and Adolescents, who serve many of the children with mental health challenges and their families. This year the rally will be held on Wednesday, May 8, at 11:00am on the North steps of the Capitol. Last week I spoke to John Magill, Director of the Department of Mental Health, who speaks at the rally each year. I asked if he thought there may be a possibility of Governor Haley attending and reading the Proclamation that she will sign designating May 5-11, 2013 as Children's Mental Health Awareness Week in South Carolina (the Proclamation has already been requested).
