"259; PAROLE LAW" INTERSTATE CORRECTIONS COMPACT ... Is for PRISONERS who wish to RELOCATE BACK To Their HOMETOWN, PLACE of Birth etc.

It is also a legal tool to USE AGAINST the PAROLE BOARD WHEN they try to USE the, ARE YOU COMPATIBLE WITH THE WELFARE OF SOCIETY."

This assumption was adduced without taking ANY of Mr., HARTSELL, YEARS of REHABILITATION into consideration.

The strange thing is that in EACH institutional goals STATES:

I'm being "tried" all over again for the very same crime in which I've already PLED GUILTY to and served 24 straight years for. I know that my Constitutional and Civil Rights Both HAVE BEEN VIOLATED.

If released, Mr. HARTWELL, would be seeing (Ms. TIFFANY MUNN, Community Service Coordinator in the further)...

New York City, would NEVER have to worry about seeking me ever again. I'm 59 years old now, and I HAVE LEARNED from these 24 years that there's nothing that could EVER happen that would put me in a state of mind to MAKE A BAD CHOICE in judgment. Twenty-four years behind these prison walls have taught me numerous lessons learned that if giving the chance; opportunity to be released, I would be doing a lot of giving back to society by Advocating my experiences to the youth in hopes of touching just one troubled youth.

"Section 70.40 of the New York Penal Law, Section 803 of the Corrections Law, and Section 259-i of the Executive Law lay out in detail the requirement for parole and conditional release. Your eligibility depends on the type of sentence you were given; the number of sentences you were given; In sum, the law states that you are eligible for parole after serving your minimum sentence. "DUE PROCESS of law should be considered before depriving people of life, liberty or property."

As each inmate is received by the Department of Correctional Services, the Board determines the need for further investigation of the background of the inmate and ensures that the investigation if needed, is done expeditiously.
