**CALL TO ORDER AND PRAYER**

Chairman J. Matthew Rivers welcomed everyone and asked Council Member Bruce E. Rivers to open the meeting with prayer.

**ADOPTION OF AGENDA**

It was proposed to amend the Agenda to add item 6b, the temporary appointment of a Clerk to Council. It was proposed to also add an item to Executive Session, being an Economic Development briefing. Council Member Johnson made a motion to adopt the August 11, 2010 meeting agenda with any amendments approved by Council. Council Member Cole seconded the motion. Voting in favor of the motion was unanimous.

Council Member Bruce E. Rivers made a motion to pass 1<sup>st</sup> reading by title only. Council Member Miller seconded the motion. Voting in favor of the motion was unanimous.

## **ITEMS SUBMITTED BY COUNCIL**

This item was discussed in essence to codify what has been the customary practice in regards to board appointments. If a board has nine members appointed by each individual Council Member, then Council does not have to vote on this. The Council Member simply gives the Administrator the name of the appointee and that appointee becomes a member at that time. The Administrator will then send out a formal letter and will announce the appointee

at the next Council Meeting. If Council appoints less than nine members as a group, then that does require a vote.

The recommendation has been made to clarify this in the standing rules and add this as item 37 in those rules.

Motion to add this clarification (using the proper wording) to the Standing Rules to make this the 37<sup>th</sup> rule was made by Council Member Cole. Council Member Powe seconded the motion. Voting in favor of the motion was unanimous.

### **ITEMS SUBMITTED BY STAFF**

#### **a. Take Home Vehicles – Douglass**

Interim Administrator Douglass discussed the take home vehicle issue with Council in regards to there being many varying opinions as to which employees should be allowed to take their vehicle home. Interim Administrator Douglass passed out a list of the 11 vehicles that she has control over. It was decided that Council would mark the ones that they feel should be parked and work with the Administrator during the month with the majority ruling.

#### **b. Statewide Court Case Management System – Cheraw Magistrate Office**

The discussion on this was in regards to the Statewide Court Case Management System. The County is in line to be funded more than \$255,000 for deployment of this system. In order for the Cheraw Office to be included, the County must have an office set up immediately. The issue of an office in Cheraw was discussed during the early part of the year.

Council Member Bruce E. Rivers made the motion to set up a full time Cheraw Magistrate Office to be implemented by the Administrator in conjunction with our Chief Magistrate and the Cheraw Magistrate, in the form or manner that deems fit with personnel as our Chief suggests. Council Member Cole seconded the motion. Voting in favor of the motion was unanimous.

At the COG meeting last night, she found out that the Rural Transportation Guide Chairs went up \$1.5 million dollars. Last time it was 7.8 now it is 9.3 as a result of vehicle miles traveled rather than just by population. This gives the Pee Dee area an additional \$1.5 million dollars.

In reference to the Road Sign Theft Ordinance, the County will give the citizens that may have any signs the opportunity to bring them back to the County without any repercussions. This will be during the passing of the ordinance; once the ordinance passes, then the persons will be charged. We are looking at about \$100 for restitution and the Magistrates state that the fines could be up to \$1,080 per sign. Mrs. Powe asked that the press let the public know.
