Dear Governor Haley:

Enclosed is a copy of Act No. 199 of 1991, which created the Newberry County Registration and Election Commission. There have been seven (7) members appointed by the Governor upon the recommendation of the Newberry County Legislative Delegation, including the senator. In past years, members of the Commission were appointed for a term of two (2) years, and any vacancy was filled by appointment for the unexpired term only. In the past, all seven terms traditionally commenced on July 1 of odd-numbered years and expired two years later on June 30 of odd-numbered years.

Mr. Henry B. Summer was appointed on May 24, 2012, for an unexpired term to expire on June 30, 2013. Mr. Summer's service has continued in a holdover status.

Also enclosed is copy of Act 196 of 2014 which creates County Boards of Voter Registration and Elections.




