Thank you for generous time when we met on October 18, to discuss South Carolina Life Sciences and our Personalized Medicine Awareness Day Event. We made these points:

- South Carolina has a significant life sciences sector.
- Innovation jobs are the key to growing great jobs here in South Carolina.
- Creating innovation jobs requires the same kind of enthusiasm and successful policies as industrial recruitment.
- Developing innovation-based companies requires a kind of "site prep" and the early stage funding often requires some state encouragement to lower costs or reduce risk. -- Just like industrial recruitment. We do not advocate direct investment into companies.
- There is a growing, changing sector in clinical genomics or personalized medicine in South Carolina.
