I am writing in complaint of the Medicaid services here in Lexington County, South Carolina. My husband has been under their care. They were requesting our tax forms for 2012. I turned them in late so they removed him from the program. I turned the forms in they requested on July 1st and they informed me that it would take about 30 days to process. It is now August 18 and we still haven't heard from them.

My husband has had 7 back surgeries and is in constant pain. He is on a lot of medicine. Most of the medicine, he's been on them for so long that he cannot stop taking them or he will go into withdrawal shock. The morphine dosage he takes is so high that if he stops taking them, his heart could stop. We cannot afford the medicine and if Medicaid does not approve it soon, we cannot purchase them for him.

The doctor set up for him to go to rehab and a phyciatrist. A Medicaid worker told us that we had to cancel our appointments. He could have been off the medicine if they had only put him back onto Medicaid.

My pain management doctor, Dr. Durrett, dropped him as a patient because we could not pay for the last appointment and we did not have Medicaid. I have to look for a new doctor but no one will accept us because we don't have Medicaid or insurance.

I don't know why they are taking so long to put him back on. Nothing has changed and I was assured he would be back on soon. I have called the Medicaid office several times but no one ever answers, and I am not exaggerating. I went to the office, asking to speak to whomever is in charge, and the lady told me to wait, that she was on the phone, that it would take about 10 minutes. I waited over 30 minutes and asked her if it would be much longer. She went back to check and

came back and told me that sheâ€™s still on the phone. I asked her, â€œIâ€™m not going to be seen, am I?â€ She responded that I wonâ€™t. I told her my story and asked her to write it down and give it to her supervisor. She said she would. I still havenâ€™t heard from anyone. I am very worried that my husband will not get the help he desperately needs and that he will get hurt or even die. I feel that no one wants to help. All I need is for them to look over the forms and re-approve it. I kn!

ow we are still eligible.

One of the caseworkers advised me to write to you. If you could please help me, I would highly appreciate it. I also feel that the supervisors really need to take their work seriously. People are relying on them and they wonâ€™t answer the phone. Not all of them are negligent, but a lot of them are. One worker, named Ms. Roach, was extremely helpful. She gave my husband her number and was going to help us out. Unfortunately, my husband misplaced it. When I went to the Medicaid office, I asked them for her number. They found about 10 people with the last name Roach so they didnâ€™t know which number to give me.

So if you can help me out, I would appreciate it.


Dear Mrs. Askar:
