Friends,

I am humbled and grateful at finishing in first place with 38 percent of the vote in my first run for public office. I want to thank you for your votes - I have received an outpouring of support from friends in Chapin, Irmo, and Lexington since Election night on Tuesday. As you may have seen, I have carried many precincts in District Six from Amicks Ferry in Chapin to precincts in Lexington because of your support.

But our work is not done - and we take nothing for granted. Our runoff election is just 11 days away. If you will be out of town on Tuesday, June 28, please vote before you leave.

Absentee voting begins on Monday, June 20. You may visit the Lexington County Election Commission and vote in person beginning Monday, June 20 - they will also be open on Saturday, June 25 from 8-11 am. They are located at 605 West Main Street, Suite 105 in Lexington. All you have to do in the office is fill out an absentee application and cast your vote in the commission office. You can also call them at (803) 785-8361 and ask them to mail you an absentee ballot. Absentee voting ends on Monday, June 27 at 5 pm. If you will be out of town on Tuesday, June 28, I would appreciate your absentee vote. The majority of absentee ballots cast on Tuesday went in our favor; if you have neighbors you know who will be out of town on Tuesday, June 28, please remind them to vote absentee in person or by mail before they leave.

It's time for change in Lexington County and new conservative leadership. This runoff election rests on voter turnout and grassroots activism from voters like you. Please call, text, and encourage your family, friends, and neighbors about the importance of voting for me for County Council District Six. There are three other countywide races on the June 28 ballot in runoffs: Solicitor General, Clerk of Court, and Register of Deeds.

This weekend, please start reminding your family, friends, and neighbors of the importance of voting for me and encourage them to vote in person or request an absentee ballot by mail if they will be out of town on Tuesday, June 28. My team and I are working incredibly hard to finish this race - with your grassroots support in your neighborhoods, I know we can get the job done.

Lastly, if you will be voting on Tuesday, June 28 in person, I am asking you to please serve as a poll greeter on my behalf at your home voting location. There are 13 voting locations in District Six and I can spend time at one of them. I need people like you at the other 12 locations throughout the day from 7 am to 7 pm serving in shifts. Poll greeters are allowed to stand 200 feet away from the voting location and simply smile and greet people as they walk in to vote and encourage them to vote for me (you can bring a lawn chair and tablet or book to pass the time in between greeting people). Poll greeters are not allowed to wear campaign stickers or shirts - but they can certainly smile and be cheerful on my behalf! Please email or text me the times you can serve as a poll greeter.
