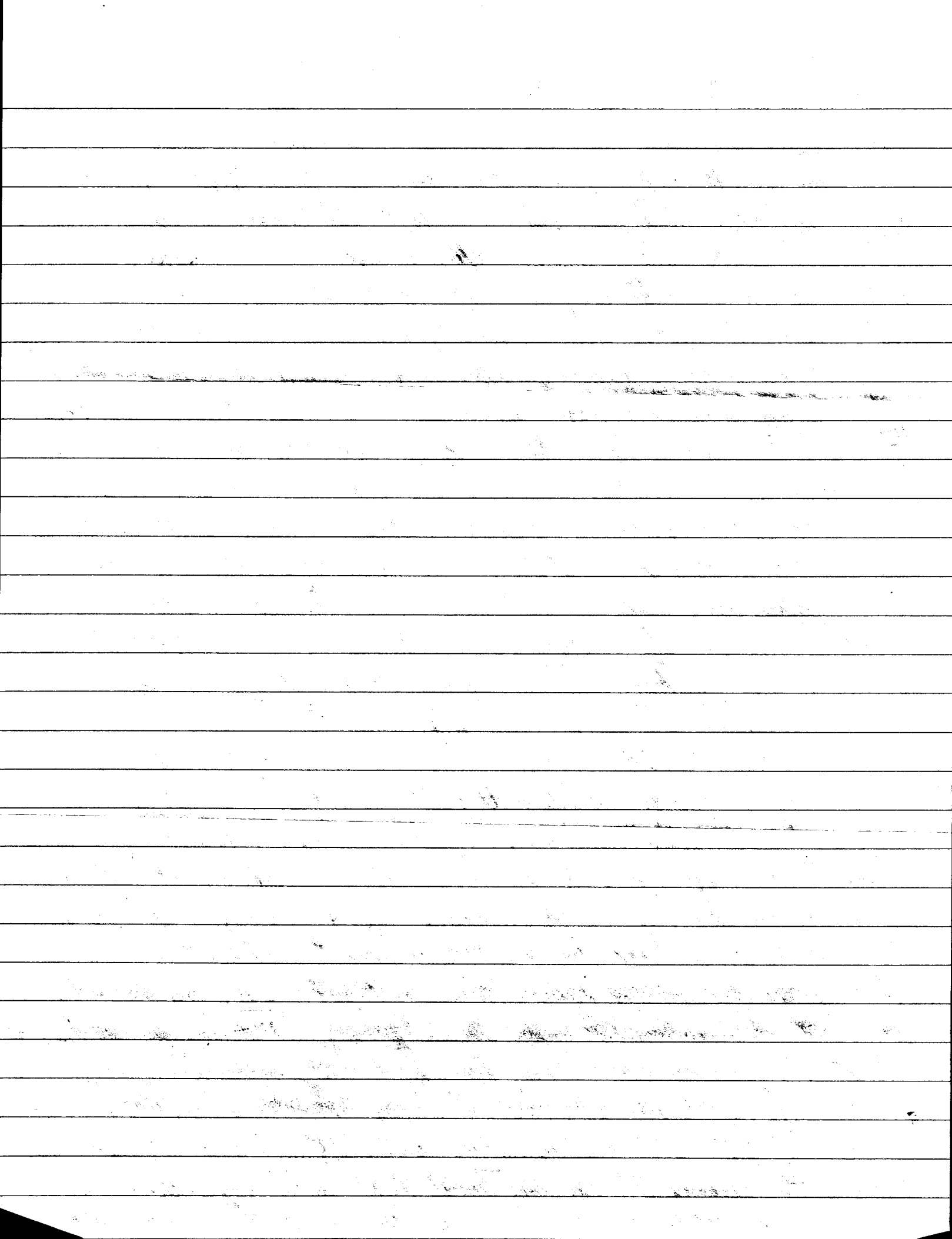


The Honorable Governor Nikki Haley

Each Judge Shalgrove told me she didn't trust me no further than she could throw me, also she has no sympathy for me before I ever got on the stand.
