MINUTES OF BUDGET AND CONTROL BOARD MEETING

JULY 10, 1963

- o -

The Budget and Control Board met in the Conference Room of the Governor's Office at 10:30 A. M., Wednesday, July 10, 1963, with all members present. Also present were P. C. Smith, Assistant State Auditor and Walter B. Brown, Director of the Division of Sinking Funds and Property.

The following business was transacted.

1. SECRETARY OF STATE - Allocation from Civil Contingent Fund

Mr. O. Frank Thornton, Secretary of State, appeared before the Board with a request for an allocation of \$6,379.90 from the Civil Contingent Fund for office equipment and other expenses of his office. Mr. Thornton stated that the corporation laws of the State were revised during the closing days of the 1963 session of the General Assembly which will necessitate considerable additional clerical processes in his office. Additional equipment and supplies will be needed.

He estimated total needs to be \$9,379.90, for which an appropriation of only \$3,000.00 was available.

The Board unanimously approved this request.

2. MENTAL HEALTH COMMISSION - Salary Transfer

The Mental Health Commission requested the Board to approve a transfer of \$14,000.00 from the 1963-64 appropriation for the position of Director of the Mental Health Commission to a new position of Deputy Director of Community Mental Health Services.

This request was to conform to a change in organization whereby Dr. W. P. Beckman, formerly Director of the Mental Health Commission, is to become Deputy Director of Community Mental Health Services without change in salary.

The Board unanimously approved the requested transfer.

3. WILDLIFE RESOURCES COMMISSION - Survey of Records

At the request of the Wildlife Resources Commission, the Board unanimously approved their employment of Arthur Andersen & Company, Certified Public Accountants, to make a study and recommendations of the financial records system of the Commission. It was understood that this service will cost approximately \$5,000.00 and will be paid from funds available to the Commission.

4. SOUTH CAROLINA SANATORIUM - Transfer for Detention Ward

Dr. Rudolph Farmer, Superintendent of the South Carolina Sanatorium, requested the Board to approve a transfer of \$25,000.00 from the 1963-64 appropriation for County Sanatoria to provide funds to construct a detention ward at the Sanatorium. The purpose of this ward would be to prevent certain patients committed to the Sanatorium by local authorities from leaving before being formally dismissed by Sanatorium authorities.

The Board noted that this request had previously been before it for consideration. After full discussion, the request was rejected.

5. STATE HIGHWAY DEPARTMENT

The Highway Department requested advice of the Budget and Control Board regarding a bill the department has against the Governor's office, in the amount of \$131.40, for moving household furniture of an employee of that office on October 30, 1962. Governor Russell was of the opinion that he did not have authority to pay obligations concerned with the previous administration.

The Board took no specific action with respect to the request, but indicated that there would be no objection to the cancellation of this charge by the Highway Department on its records.

6. STATE DEVELOPMENT BOARD - Adjustment of Appropriated Salaries

The State Development Board authorities called attention to three line item salaries in their appropriation for 1963-64 in which it was rather obvious that the General Assembly had unintentionally appropriated less for these

positions for 1963-64 than were paid in 1962-63. The apparent error arose from the fact that these positions were filled for only part of the year 1962-63. The amounts appropriated for 1963-64 were the same as were expended during the partial year 1962-63.

The Board approved a transfer to make available a full year's salary for each of these positions at the same rates paid in 1962-63.

7. MEDICAL COLLEGE - Approval of Porter Academy Deed

In accord with provisions of the 1963-64 General Appropriations Act the Medical College submitted for the Board's approval a draft of the proposed deed by which Porter Military Academy would convey to the Medical College the 11.3 acres now under purchase option of the Medical College.

The Board reviewed the terms as proposed and approved them unanimously without change.

8. RESOLUTION ON ISSUANCE OF \$1,305,000.00 OF STATE NOTES

Following action of the Board at its meeting June 5, 1963, the Board had before it at this meeting a formal resolution regarding the issuance of \$1,305,000.00 of State Notes. These notes are to be issued under authorization of the 1963-64 General Appropriations Act which provides for a total issuance of \$5,040,000.00 of notes.

Proceeds of the \$1,305,000.00 of notes acted upon at this time will be allocated as follows: \$1,150,000.00 to the Medical College for purchase of the Porter Military Academy property, and \$155,000.00 to the State Board of Corrections for purchase of property for the establishment of a new unit of the Penitentiary for youthful offenders.

The resolution was unanimously approved by the Board. (A copy of the resolution is attached herewith as a part of the minutes.) (No. 2)

9. FORESTRY COMMISSION - Construction of Facilities at State Parks

At the meeting of the Board March 27, 1963 the Board temporarily passed over two requests of the Forestry Commission for approval of the construction of park facilities at Huntington Beach and Hunting Island State Parks. The Commission requested that these applications be reconsidered by the Board.

After further consideration the Board was of the opinion that the proposals should be carried over again for action at some later date.

10. EDUCATIONAL FINANCE COMMISSION - Temporary transfer

The Board had before it a request of the Director of the Educational Finance Commission to approve a temporary transfer of \$2,000,000.00 from the 1963-1964 appropriation for Operation of School Busses to provide funds for the purchase of new school busses needed for 1963-64. As presented, this request was made to avoid the immediate issuance of bonds to provide funds for bus purchases in the hope that a deficiency appropriation might be obtained from the 1964 meeting of the General Assembly. Such an appropriation would eliminate the necessity of issuing bonds. In requesting this transfer it was noted that a deficiency appropriation had been made in 1962-63.

The Board unanimously approved this request.

11. RETIREMENT SYSTEM

Mr. Bates noted that the General Assembly had appropriated \$33,700.00 to the State Retirement System to cover additional administrative costs resulting from the transfer of the affairs of the Police Insurance and Annuity Fund to the State Retirement System office July 1, 1963. He called the Board's attention to the fact that the new Police Officers' Retirement System would also place additional responsibilities on employees of the State Treasurer's office. He accordingly asked the Board's approval of a portion of the above mentioned appropriation to supplement salaries of employees in his office affected by creation of the new Police Officers' Retirement System.

The Board unanimously approved Mr. Bates' request.

Mr. Bates also asked the Board's approval of an increase in the amount paid Moody's Investment Service for service rendered the State Treasurer's Office in the field of investment counseling. He indicated that for several years this service has cost \$1,800.00 per year but that he expected some increase in the future. The Board authorized the payment of such charges as may appear reasonable to Mr. Bates.

At the suggestion of Mr. Bates the Board reviewed the retirement regulation adopted January 28, 1959 relating to employment of retired persons.

The following regulation was adopted January 28, 1959:

"A person retired on a service retirement allowance from the South Carolina Retirement System with an allowance not exceeding \$1,200.00 per fiscal year may return to covered employment and earn an amount not exceeding \$1,200.00 per fiscal year without affecting his retirement allowance."

The Board approved an amendment to the above regulation whereby the words "with an allowance not exceeding \$1,200.00 per fiscal year" were deleted so that the regulation as amended will hereafter read as follows:

"A person retired on a service retirement allowance from the South Carolina Retirement System may return to covered employment and earn an amount not exceeding \$1,200.00 per fiscal year without affecting his retirement allowance."

12. COLLEGE BUILDING PROGRAMS

The Board had before it for consideration several permanent improvement projects proposed by Clemson College, Winthrop College and the University of South Carolina.

In most instances the construction of these projects would require the issuance of State Institution Bonds. In view of the extent of bonds issued under the program in recent years and the consequent addition of facilities at these institutions, the Board was of the opinion that a general study of the needs

of the State's Institution of Higher Learning should be made before an extensive building program should be undertaken.

The Board accordingly deferred action on the request of these institutions at this time until such a study can be made.

13. EMPLOYEE SALARY INCREASES - 1963-64

The State Auditor's office presented to the Board a list of proposed increases in salaries of certain supervisory personnel within the State Government to become effective July 1, 1963. (A list of these positions with the proposed increases is attached herewith as a part of the minutes.) (No. 3)

The Board reviewed the list in detail and approved it without change.

The Board had before it a request of General Mark Clark, President of The Citadel, to allow the payment of amounts ranging from \$100.00 to \$500.00 for certain personnel at The Citadel for meritorious service during the year 1962-1963.

The Board considered this as being somewhat in the nature of a "bonus" at the end of the fiscal year and felt that it had no authority to authorize this type of compensation. The request was accordingly disapproved.

14. REQUEST FOR LICENSE TO MINE PHOSPHATE DEPOSITS - BEAUFORT COUNTY

Mr. Joab Dowling, Dick Pollitzer and former Senator Burt Rodgers, of Beaufort County, appeared before the Board representing the Carolina Mining Company, a Beaufort County organization interested in the mining of phosphate deposits located on State-owned lands in Beaufort County. Their application for a license was being made under the terms of an Act of the 1963 General Assembly.

After reviewing the request and a general discussion of the proposed mining operation, the Board agreed to grant a license as authorized by the Act. Details of the license, including royalties and other terms, are to be determined by the State Geologist and the Director of the Division of Sinking Funds and Property. It was understood that royalties at the rate of 2½% of gross sales would be included in the terms.

15. BUSHY PARK AUTHORITY

The Board briefly discussed the status of the State's loans to Bushy Park Authority. It was decided that a full discussion of this matter would be scheduled for the next meeting of the Board. Mr. Walter Brown, Director of the Division of Sinking Funds and Property, was accordingly requested to prepare a report on this subject for the next meeting.

16. CLEMSON ARMORY

Adjutant General Frank D. Pinckney appeared before the Board in the interest of securing funds for the construction of a new armory to serve the general community around Clemson College.

It was noted that the 1963 General Assembly had discussed an appropriation for this purpose but that no amount had been included in the Appropriations Act finally passed. It was also indicated that the Legislative Delegations of Anderson, Oconee and Pickens Counties had agreed to advance a total of \$45,000.00 for the construction of this armory provided the Budget and Control Board would agree to recommend an appropriation of this amount to the 1964 General Assembly.

The Board unanimously adopted the following resolution regarding this matter:

"WHEREAS, The Budget and Control Board has been informed that the Free Conference Committee on the 1963-64 General Appropriation Act intended to include in its report an item of \$45,000.00 to the Adjutant General's Office for construction of an armory at Clemson; and

WHEREAS, Apparently through misunderstanding, the item was not carried in the Committee's Report; and,

WHEREAS, In order that construction of this armory may not be further delayed, the Legislative Delegations of Anderson, Oconee and Pickens Counties have agreed to advance a total of \$45,000.00 to the Adjutant General's Office for this purpose, provided the Budget and Control Board will agree to recommend to the 1964 General Assembly that an appropriation of \$45,000.00 be made to reimburse them for this advance;

NOW, THEREFORE, BE IT RESOLVED by the Budget and Control Board that it will recommend to the 1964 General Assembly that it appropriate \$45,000.00 to reimburse Anderson, Oconee and Pickens Counties for funds advances for the construction of the Clemson Armory."

17. STATE PORTS AUTHORITY - Engineering Survey

Governor Russell informed the Board that he had had considerable discussion with officials of the State Ports Authority regarding the general need of a study of certain phases of the Authority's physical facilities. It has been generally agreed that an engineering study would be appropriate.

In view of the fact that the Santee-Cooper Authority would likewise be interested in that part of the study relating to the Cooper River, the matter has been discussed with them also, with the following being recommended:

"The State Ports Authority and the Public Service Authority shall employ an engineering firm (1) to review all available material, including any studies, models and tables prepared by the Corps of Engineers, relating to the operation and maintenance of the Charleston port, and (2) to consider, evaluate, and advise with said Ports and Public Service Authorities, as well as any other responsible agency of the State Government, with reference to a means to improve the present and future operation and maintenance of such port, to enlarge its channels, to promote sanitation, to protect fish and game, and to reduce any avoidable silting therein.

The costs of such employment shall be divided between the Ports Authority and the Public Service Authority.

The engineering firm shall be jointly selected by the Ports Authority and the Public Service Authority. Should they be unable to agree on an engineer, each shall submit to the Budget and Control Board the names of these engineering firms, from which the Budget and Control Board shall select the engineer."

The Board unanimously approved the above proposed action.

18. STATE-OWNED AUTOMOBILES

Governor Russell called the Board's attention to the fact that considerable interest has developed in the matter of regulations of the use of State-owned automobiles and other vehicles and suggested that the Board give consideration to the development of suitable rules for the use of such equipment.

The State Auditor's Office was accordingly requested to secure information from the various departments and institutions as to the number of vehicles owned and general practices as to restricted use of them. Further consideration will be given this subject when this information has been secured.

17. STATE PORTS AUTHORITY - Engineering Survey

Governor Russell informed the Board that he had had considerable discussion with officials of the State Ports Authority regarding the general need of a study of certain phases of the Authority's physical facilities. It has been generally agreed that an engineering study would be appropriate.

18. STATE-OWNED AUTOMOBILES

Governor Russell called the Board's attention to the fact that considerable interest has developed in the matter of regulations of the use of State-owned automobiles and other vehicles and suggested that the Board give consideration to the development of suitable rules for the use of such equipment.

The State Auditor's Office was accordingly requested to secure information from the various departments and institutions as to the number of vehicles owned and general practices as to restricted use of them. Further consideration will be given this subject when this information has been secured.

19. CONSOLIDATION OF APPROPRIATIONS

The Board authorized the Comptroller General to consolidate into a single maintenance appropriation account the detailed appropriations in the 1963-1964 General Appropriations Act for those departments and institutions generally referred to as "lump sum" departments. The Board was of the opinion that the itemization of appropriations for these departments and institutions would bring about unreasonable administrative difficulties and that the efficiency of operation of these departments would be best served by the proposed consolidation. It was also noted that appropriations to these departments and institutions had formerly been made in a single maintenance account.

20. OIL LEASES

Mr. Walter Brown informed the Board that negotiations were in process with several prospects for the lease of off-shore oil rights. As yet no arrangements have been concluded and he was authorized by the Board to continue these negotiations.

21. EASEMENTS GRANTED

The Board authorized the Director of the Division of Sinking Funds and Property to grant two right-of-way easements on State property of the John G. Richards Industrial School and the S. C. Department of Corrections.

22. CONVERSION OF STATE BUILDINGS TO GAS HEAT

The Board was informed by Mr. Walter Brown that a preliminary study of the feasibility of converting the heating systems of several State-owned buildings and other facilities in the City of Columbia had indicated that a substantial reduction in heating costs might result from such a conversion. At his suggestion the Board authorized a more intensive study of this matter and authorized an expenditure of \$5,000.00 for this purpose from the Ordinary Sinking Fund.

23. EMPLOYMENT OF WILLIAM N. GEIGER, JR.

The Board authorized the employment of William N. Geiger, Jr., formerly associated with the State Engineer, as a consultant in connection with

the planning and construction of the proposed new State Office Building on Senate Street, and the new administrative facilities for the State Board of Health. Details of the arrangement were left to the Director of the Division of Sinking Funds and Property.

24. USE OF STATE WAREHOUSE BY PENITENTIARY

The Board authorized the authorities of the State Penitentiary the temporary use of the State-owned warehouse building located at the corner of Lady and Lincoln Streets in the City of Columbia. (This property is generally known as the "Fish House".)

25. PURCHASE OF McCOY PROPERTY AUTHORIZED

Mr. Walter Brown informed the Board that the McCoy property, located on the South side of the 1400 Block of Senate Street in the City of Columbia, was available for purchase by the State for \$55,000.00 and recommended its purchase. After full consideration of the matter, Mr. Brown was authorized to contract for the purchase of this property at the price indicated, provided a favorable opinion could be had from the Attorney General as to the purchase of this property as an investment of the Ordinary Sinking Fund.

No further business was transacted and the meeting adjourned at 12:30

Re: Property of the Porter Academy in Charleston

Gentlemen:

This letter is written for the purpose of obtaining the approval of the State Budget and Control Board to the terms and conditions of the conveyance by which The Medical College of South Carolina seeks to acquire the present school site and properties of the Porter Academy located in the City of Charleston.

Under date of March 8, 1963, The Medical College procured an option for this property, a conformed copy of which is enclosed. Appended to the option was a plat, also enclosed, which sets forth certain areas of the property which are to become immediately available to the Medical College following the delivery of the Deed. The remaining properties are to be utilized by Porter for school purposes until it decides to vacate them or until July 1, 1965, whichever shall first occur. Following the delivery of the option certain modifications have been made therein.

The first and most important of these relates to the amount of the purchase price. It was originally provided that Porter should have the option to accept in payment of the property the sum of \$975,000, plus certain property of the Medical College referred to as "The Fort Johnson Property," or in lieu thereof the sum of \$1,136,000. Porter has decided that it does not require the Fort Johnson property and hence it has been agreed between representatives of the College and Porter Academy that the purchase price for the property is to be entirely in cash, and will be the sum of \$1,136,000. Under the terms of the option the land to be made available to the College on the occasion of the closing was subject to the condition that the Medical College utilize such properties for construction purposes. That provision has

now been deleted and it has been agreed that no limitation whatsoever is to be put upon the use of the areas to be made available to the Medical College at the time of the closing. This has some significance as the College has plans to utilize the western property for parking and other purposes.


Porter is to have the right, if it elects, to dismantle and to utilize the salvage of two buildings on the property. These are the buildings known as The Old Federal Arsenal (shown on the enclosed plat as the 3-1/2 story brick main building) and the Chapel.

To sum up, the transaction is as follows:

Porter will convey the property to the Medical College upon payment of the sum of \$1,136,000. There will be no conditions or reversions in this Deed, but, simultaneously with the settlement, the Medical College will give written assurance to Porter that it may utilize all of the property not marked on the enclosed plat as being made available to the College, for school purposes until July 1, 1965, and Porter is to have the salvage rights above set forth.

This letter is written in order that the Medical College may obtain the approval of your Board to the terms and conditions of the transaction, as required by Section 9 of Part II of the State Appropriations Act for the fiscal year beginning July 1, 1963.

A RESOLUTION

MAKING PROVISION FOR THE ISSUANCE OF \$1,305,000 OF NOTES OF THE STATE OF SOUTH CAROLINA FOR THE PURPOSE OF RAISING MONEYS FOR THE MEDICAL COLLEGE OF SOUTH CAROLINA AND FOR THE STATE BOARD OF CORRECTIONS FOR FURTHER FACILITIES FOR SUCH INSTITUTIONS.

BE IT RESOLVED BY THE STATE BUDGET AND CONTROL BOARD OF THE STATE OF SOUTH CAROLINA:

ARTICLE I

FINDINGS OF FACT

As an incident to the adoption of this Resolution the State Budget and Control Board of the State of South Carolina finds that the facts set forth in this Article are in all respects true and correct:

1. By the provisions of Section 9 of Part II of an Act of the General Assembly of the State of South Carolina, entitled "AN ACT TO MAKE APPROPRIATIONS TO MEET THE ORDINARY EXPENSES OF THE STATE GOVERNMENT FOR THE FISCAL YEAR BEGINNING JULY 1, 1963....., TO PROVIDE FOR THE ISSUANCE OF STATE NOTES IN THE AMOUNT OF \$5,040,000ETC." (the Enabling Act), it is provided that if the State Budget and Control Board (the State Board) shall express its approval by proper resolution, the Governor and the State Treasurer shall be empowered to issue Notes of the State of South Carolina to the extent of not exceeding \$5,040,000 and to apply the proceeds thereof to the purposes enumerated in Paragraphs numbered 1, 2, 3, 4 and 5 of said Section 9.

2. By paragraph numbered 1 of said Section 9 it is provided, among other things, that the sum of \$1,150,000 may be raised through the issuance of Notes for the purpose of paying the consideration and other expenses incident to a conveyance by which the Porter Academy will deed to the Medical College of South Carolina (the Medical College) certain property in the City of Charleston, more particularly set forth in said paragraph 1. Said paragraph 1 requires, as a condition precedent to such action, that the State Board shall approve the consideration to

be paid to the Porter Academy and the terms and conditions of the conveyance to the Medical College.

3. A memorandum outlining the consideration (the sum of \$1,136,000) and the terms and conditions of the conveyance has been presented to the State Board and has been approved.

4. By paragraph 2 of said Section 9 of the Enabling Act the State Board of Corrections (the Board of Corrections) is empowered to acquire an appropriate site and to construct thereon facilities estimated to cost \$1,500,000. Acting on the assumption that it would be empowered to acquire a site, the Board of Corrections has procured an option for the purchase of a tract of land in Berkeley County, South Carolina, at a cost of \$155,000. It is necessary that such option be exercised, and for that reason it is necessary to raise \$155,000.

5. The State Board has given due consideration to the other matters for which State Notes may be issued pursuant to said Section 9 of the Enabling Act, but has decided to defer action thereon until a later date. In so determining, the State Board does not waive, but on the contrary, expressly reserves its rights to issue the remaining notes authorized pursuant to said Section 9 of the Enabling Act under the conditions hereafter stated.

6. Notes issued pursuant to said Section 9 are to be payable from, and secured by a pledge of, the revenues derived from the tax imposed pursuant to Article 1, Chapter 12, Title 65, Code of Laws of South Carolina, 1962.

7. Such revenues are, as of this occasion pledged to secure the following outstanding obligations of the State of South Carolina, all of which are held by the State Board in its capacity as Trustee of the funds of the South Carolina Retirement System, viz.:

(a) The now outstanding \$1,062,500 of an original issue of \$2,125,000 State Notes, dated 2-1-58, issued for various State Institutions.

(b) The now outstanding \$200,000 of an original issue of \$300,000 State Notes, dated 10-1-57, issued for Clemson College.

(c) The now outstanding \$130,000 of an original issue of \$150,000 State Notes, dated 8-1-60, issued for Clemson College.

(d) The now outstanding \$130,000 of an original issue of \$150,000 State Notes, dated 8-1-60, issued for the University of South Carolina.

(e) The now outstanding \$200,000 of an original issue of \$300,000 State Notes, dated 10-1-57, issued for the University of South Carolina.

(f) The now outstanding \$140,000 of an original issue of \$200,000 State Notes, dated 7-1-59, issued for the Archives Department.

(g) The now outstanding \$1,500,000 State Penitentiary Notes, dated 11-1-62.

8. In order that no question may arise as to whether the pledge made to secure the Notes to be issued pursuant to said Section 9 of the Enabling Act shall be on a parity with the pledges securing the aforesaid obligations, it has been determined that the State Board, in its capacity as aforesaid, should agree thereto and shall cause evidence of such agreement to be made known as hereinafter provided.

On the basis of the foregoing findings and for the purpose of raising the sum of \$1,305,000, the State Board by this Resolution undertakes to:

(1) Approve the consideration and the terms and conditions of the acquisition by the Medical College of the Porter Academy property, and to make the sum of \$1,150,000 available for such acquisition and such other expenses as may be incident thereto;

(2) Approve the acquisition by the Board of Corrections of a tract of land in Berkeley County, South Carolina, and to make the sum of \$155,000 available therefor; and

(3) Authorize the Governor and the State Treasurer to issue Notes of the State of South Carolina to the extent of \$1,305,000.

(4) Fully reserve to itself the right to issue additional notes pursuant to Section 9 of the Enabling Act under the terms and conditions hereinafter set forth; and

(5) Consent that the pledge securing the notes authorized hereby and other notes issued pursuant to Section 9 of the Enabling Act shall be on a parity with the pledges made to secure the present outstanding obligations of the State of South Carolina enumerated in Paragraph 7, supra.

ARTICLE II

ISSUANCE OF NOTES

Section 1.

Pursuant to the provisions of Section 9 of the Enabling Act, the State Board authorizes and empowers the Governor and the State Treasurer to issue \$1,305,000 of Notes of the State of South Carolina, to be designated "State Notes, First Series of 1963" (the Notes), whose proceeds shall be expended as follows:

(a) Not exceeding \$1,150,000 shall be made available to the Medical College in order that it may pay the consideration and other expenses incident to the acquisition of certain property in the City of Charleston from Porter Academy, more fully described in said Section 9 of the Enabling Act; and

(b) Not exceeding \$155,000 shall be made available to the Board of Corrections to enable it to acquire a tract of land in Berkeley County, South Carolina.

Section 2.

The Notes shall be issued in fully registered form and as a single fully registered note, in the name of the State Budget and Control Board of South Carolina, as Trustee of the funds of the South Carolina Retirement System, and payable to said Budget and Control Board of South Carolina, as Such Trustee, or to its assigns.

Section 3.

The Notes shall be dated July 1, 1963, shall bear interest at the rate of four and one-half per centum (4-1/2%) per annum, from the date of the delivery thereof (as established by the certification endorsed thereon), payable on the 1st days of January and July of each year, commencing January 1st, 1964, until the principal amount shall be paid in full, and shall mature in annual instalments on July 1 in the years and in the amounts set forth below, as follows, viz.:

Section 4.

The State of South Carolina reserves the right to effect the prepayment, on any interest payment due after July 1, 1965, of any portion of the indebtedness evidenced by said Notes that it may determine upon, in the inverse chronological order of the maturities of the principal instalments, and in multiples of \$5,000, at a redemption price equal to the par value of the principal amount so redeemed, and accrued interest to the date fixed for redemption, plus a redemption premium equal to 2% of the principal amount so redeemed.

If the option to redeem shall be exercised, notice of redemption shall be given to the holder of said Notes, at least thirty (30) days prior to the prepayment date, by mailing to such holder a notice prescribing such prepayment date and specifying the amount of principal (and premium) to be prepaid.

Section 5.

Payment of interest and instalments of principal of said Notes and portions thereof (if the privilege of prepayment be

exercised) shall be effected by check or draft drawn by the State Treasurer. Such payments shall be effected by the use of funds pledged for the payment of the principal and interest of the Notes. All payments of principal and interest shall be duly endorsed upon the payment record appended to said registered note.

Section 6.

The Notes shall be executed on behalf of the State of South Carolina by the Governor and State Treasurer. The Great Seal of the State shall be affixed thereto and the same shall be attested by the Secretary of State.

Section 7.

For the payment of the principal of and interest on said Notes there are hereby irrevocably pledged so much of the revenues derived from the tax imposed pursuant to Article 1, Chapter 12, Title 65, Code of Laws of South Carolina, 1962, as shall be required to effect the prompt payment of the principal and interest thereof, as the same shall respectively mature. The pledge made to secure the Notes of this issue is hereby declared to be on a parity with the pledges now existing and hereafter made to secure the following obligations, viz.:

(a) All Notes hereafter issued pursuant to Section 9 of the Enabling Act;

(b) All obligations of the State of South Carolina authorized hereafter by legislation subsequently enacted; and

(c) The obligations enumerated in paragraph 7 of Article I, supra, secured in whole or in part by a pledge of the revenues derived from the tax imposed pursuant to Article 1, Chapter 12, Title 65, Code of Laws of South Carolina, 1962.

All moneys received by the State Treasurer from the tax above referred to shall be duly impounded by him to the extent required to provide for the payment of the principal of and interest on the Notes herein authorized, other notes hereafter issued on a parity therewith, and all existing obligations here-

tofore issued, secured in whole or in part by a pledge of the aforesaid revenues:

Section 8.

The State Budget and Control Board, in its capacity as the owner and holder of the following outstanding Notes, viz.:

- (1) The now outstanding \$1,062,500 of an original issue of \$2,125,000 State Notes, dated 2-1-58, issued for various State Institutions;
- (2) The now outstanding \$200,000 of an original issue of \$300,000 State Notes, dated 10-1-57, issued for Clemson College;
- (3) The now outstanding \$130,000 of an original issue of \$150,000 State Notes, dated 8-1-60, issued for Clemson College;
- (4) The now outstanding \$130,000 of an original issue of \$150,000 State Notes, dated 8-1-60, issued for the University of South Carolina;
- (5) The now outstanding \$200,000 of an original issue of \$300,000 State Notes, dated 10-1-57, issued for the University of South Carolina;
- (6) The now outstanding \$140,000 of an original issue of \$200,000 State Notes, dated 7-1-59, issued for the Archives Department; and
- (7) The now outstanding \$1,500,000 State Penitentiary Notes, dated 11-1-62.

hereby consents that the pledge securing the Notes hereunder shall be on a parity in all respects with the pledges securing the outstanding Notes now held by it and above described. The State Treasurer is hereby authorized and empowered to place upon the face of each of said Notes enumerated above a written statement as follows:

"The pledge of revenues derived from the tax imposed pursuant to Article 1, Chapter 12, Title 65, Code of Laws of South Carolina, 1962, has been placed on a parity with a pledge made to secure all notes issued pursuant to Section 9 of Part II of an act entitled "AN ACT TO MAKE APPROPRIATIONS TO MEET THE ORDINARY EXPENSES OF THE STATE GOVERNMENT FOR THE FISCAL YEAR BEGINNING JULY 1, 1963....., TO PROVIDE FOR THE ISSUANCE OF STATE NOTES IN THE AMOUNT OF \$5,040,000.....ETC." (The State Appropriation Act for 1963-1964).

AT MEETING

July 10, 1963

1. SECRETARY OF STATE

Thornton appears before Bd.

Frank Thornton has written each member of the Board regarding his need of additional funds for office equipment. This need arises out of an amendment to the Corporation Laws passed near the end of the 1963 General Assembly. There was not sufficient time to request additional funds in the Appropriation Act.

His letter states that he will need between \$9,000.00 and \$12,000.00.

2. MENTAL HEALTH COMMISSION

Dr. Beckman has resigned as Director of the Mental Health Commission and has taken the position of Deputy Director-Community Mental Health Services. Dr. Hall has assumed the responsibilities of Director.

There is no appropriation for Deputy Director-Community Mental Health Services. It is proposed that the \$14,000.00 appropriated for Director of the Mental Health Commission be transferred to Deputy Director - Community Mental Health Services. Dr. Beckman will thus move to the new position without change in salary. Dr. Hall will not receive any compensation specifically as Director of the Mental Health Commission.

3. WILDLIFE RESOURCES COMMISSION

Mr. Edwin W. Johnson, Chairman of the Wildlife Resources Commission has proposed the employment of Arthur Andersen and Company, a national public accounting firm to review the records system of the Commission. It is estimated that the cost of this service will be approximately \$5,000.00. The Board's approval of this study is requested.

4. S. C. SANATORIUM

Dr. Farmer has submitted a request for an appropriation transfer of \$25,000.00 from the item for "County Sanatoria" for 1963-64 for the purpose of constructing a detention ward at the Sanatorium. He states that some provision should be made for the detention of patients committed to the Institution by the several Probate Judges over the State with authorization enacted by the General Assembly some years ago. These patients do not come to the Institution voluntarily, and should not be allowed to leave until dismissed by the medical staff.

A request for an appropriation for this purpose was submitted in 1961 to the budget and Control Board, but was not recommended to the General Assembly. No request was made for this purpose in 1962.

The appropriation for County Sanatoria was reduced in 1963-64 to \$90,000.00 from \$120,000.00 last year at the request of Dr. Farmer. The proposed transfer would further reduce this item to \$65,000.00.

5. STATE HIGHWAY DEPARTMENT

The Department has a bill against the Governor's Office in the amount of \$131.40 for moving household furniture of Mr. John Altman, formerly Press Secretary to Governor Hollings, from Columbia to Charleston, October 30, 1962. Governor Russell's Office feels they do not have the authority to pay this bill.

The Highway Department has accordingly asked the Budget and Control Board for authority to write off this charge, or dispose of the matter in any other manner in which the Board may direct.

6. STATE DEVELOPMENT BOARD

Apparently through a misunderstanding, three of the line-item salaries in the Board's section of the 1963-64 Appropriation Act do not carry as much as were paid for these positions in 1962-63.

The amounts as shown expended in 1962-63 do not represent a full years salary for any of these three positions. The request for 1963-64 was based on the same rates, but for a full year. This was not explained when the appropriation request was made, and the amounts recommended were accordingly reduced to the amount being paid in 1962-63.

The Board thus needs additional funds to retain these employees at exactly the same rate of pay prevailing last year. A transfer of funds is proposed to provide the amount needed. The question arises as to whether or not such a transfer can be made which will have as its purpose the increasing of line-item salaries.

It is recommended that the transfer be approved on the basis of an obvious error in appropriating for these positions.

7. MEDICAL COLLEGE

Under the terms of the 1963-64 General Appropriation Act authorizing the issuance of notes for the Medical College, the Budget and Control Board is required to approve the deed conveying the Porter Property to the Medical College.

The proposed deed has been drafted with the following provisions:

The property involves eleven acres more or less immediately adjoining the existing Medical College property.

The purchase will be by a cash consideration of \$1,136,000.00. No property exchanges will be involved.

The deed carries no limitations or restrictive provisions as to use that may be made of the property by the Medical College.

The College will receive immediate possession of certain areas. Porter is allowed to continue the operation of their school until July 1, 1965.

Porter has a right to dismantle and salvage two of the older structures on the property.

It is recommended that the proposed deed be approved.

8. ISSUANCE OF \$1,305,000.00 OF STATE NOTES

At the meeting of the Board on June 5, preliminary approval was given to the issuance of State Notes in the amount of \$1,305,000.00 for the Medical College and the Board of Corrections. A formal resolution on the matter has been prepared by Mr. Huger Sinkler for approval by the Board.

Following are the principal provisions of the resolution.

Notes are authorized by the 1963-64 General Appropriation Act.

The proceeds will be allocated as follows:

\$1,150,000.00 to the Medical College for purchase of Porter Property, and \$155,000.00 to the Board of Corrections for the purchase of property for establishment of a unit of the Penitentiary for youthful offenders.

The notes will extend over a fifteen-year period to be retired by annual principal payments of \$85,000.00 to \$90,000.00. Interest is at 4½%.

The resolution provides for the purchase of these notes as an investment by the State Retirement System.

Revenue notes - not full faith & credit.

8. FORESTRY COMMISSION

At the meeting of the Board on March 27, 1963, the Board temporarily passed over two requests of the Forestry Commission for approval of the construction of cabins at Huntington Beach and Hunting Island State Park. The Commission has asked that these applications be presented for consideration again.

The Huntington Beach cabin will cost \$11,500.00, and the one at Hunting Island \$5,450.00. They will be constructed from funds derived by the Forestry Commission from timber sales and from an appropriation given them in 1961.

9. EDUCATIONAL FINANCE COMMISSION

The Commission has proposed a temporary transfer of \$2,000,000.00 from its appropriation for the operation of school buses for 1963-64 to pay for the purchase of new buses needed for 1963-64. The Commission requested a direct appropriation of the General Assembly to purchase buses for 1963-64. No appropriation was made by the General Assembly, it being understood that the Commission has authorization to issue bonds for this purpose.

In view of the fact that a deficiency appropriation made funds available for the purchase of buses in 1962-63, the Commission proposes to withhold the issuance of bonds this year with the hope that a deficiency appropriation may again become available when the Legislature meets in 1964.

It is recommended that the transfer request be rejected, and the Commission be required to issue bonds now as was obviously intended by the General Assembly.

10. RETIREMENT SYSTEM

Mr. Bates will bring the following matters before the Board for consideration.

- 1) The old Police Insurance and Annuity Fund is being transferred to the new Police Officers' Retirement System as of July 1. The General Assembly appropriated \$33,700.00 to the Retirement System Office to administer the new system. Some personnel in the State Treasurer's office will be effected by this additional responsibility, and should be considered in the allocation of this appropriation.
- 2) An amendment to the retirement regulations will be presented regarding maximum limitations on the amount of money that may be earned by a person on retirement.
- 3) Moody's Investment Service has been retained by the Treasurer's Office for several years in connection with the investment of retirement and other State funds. It is likely that charges for this service will be increased with the addition of investments arising out of the new Police Officers' Retirement System.

11. COLLEGE BUILDING PROGRAMS

Clemson, Winthrop and the University are currently concerned with proposed building projects and would like the Board's initial reaction to them. If no objections are raised by the Board, college authorities will proceed with further plan development, and will submit detailed, formal applications at a later date. The following are the projects under consideration:

University of South Carolina

The Board has previously passed over two applications of the University involving the construction of a Science Center estimated to cost \$2,900,000.00, and an Extension to the Administration Building estimated to cost \$180,000.00.

These projects would be financed by the issuance of \$1,250,000.00 of State Institution Bonds, the balance being on hand from a previous issue.

Clemson

Clemson proposed the construction of a new Library estimated to cost \$2,500,000.00. Funds would be provided by State Institution Bonds in the amount of \$1,000,000.00, and the issuance of \$1,500,000.00 of Clemson College Library Bonds as authorized by a 1962 Act.

Also proposed is an Addition to Facilities for the Chemistry Department estimated to cost \$950,000.00. State Institution Bonds would provide the funds.

Also, Additional and Improved Facilities for Mechanical and Industrial Engineering estimated to cost \$250,000.00. State Institution Bonds would be issued for this project also.

Also, a Central Motor Vehicle Facility estimated to cost \$50,000.00. The new Library would be constructed on the location of the present motor vehicle facility, thus necessitating this project.

Winthrop

Winthrop proposed the construction of a Student Union Building at an estimated cost of \$800,000.00 to be provided by State Institution Bonds.

The above projects would require the issuance of approximately \$4,500,000.00 of State Institution Bonds. The three institutions have agreed that the projects can be scheduled so that funds would not be needed before November 1, 1963, at which time the full amount could be made available in a single issue.

This financing would require action of the Board to use available funds to call bonds now outstanding as has been discussed by the Board previously.

✓ 11. SALARY INCREASES - 1963-64

The attached salary increases have been proposed by the several departments, and are presented for the Board's action.

✓ 12. APPLICATION FOR LICENSE TO MINE PHOSPHATE DEPOSITS

A group of citizens in Beaufort County will appear before the Board in the interest of their application to mine phosphate deposits located in Beaufort County. The application is being made under the terms of an Act of the 1963 General Assembly.

The group is scheduled to appear at 11:00 A. M. Mr. Joab Dowling of Beaufort is attorney for the group.

- ✓ 1) Oil Rights - The Sinking Fund and State Geologist were advised to continue negotiations with various prospects for lease of offshore oil rights.
- 2) Authorized the Sinking Fund Director to sign two easements of right-of-way on state property, John G. Richards Industrial School and S. C. Department of Corrections.
- ✓ 3) Authorized that an expenditure, not to exceed \$5,000, be made to continue survey of feasibility of converting various state buildings and institutions to natural gas.
- ✓ 4) Granted permission to retain William N. Geiger, Jr. on a consultant basis to determine space needs and various changes to be made in the old and new office building space allotments.
- ✓ 5) Granted to Carolina Mining Company of Beaufort, S. C., phosphate rock leases in Beaufort County; terms and royalties of lease to be determined by State Geologist and Sinking Fund.
- ✓ 6) Authorized Board of Corrections permission to use State warehouse on a temporary basis.
- 7) Instructed Sinking Fund to acquire McCoy property on Senate Street, if money and other conditions meet with the approval of the Attorney General's office.
- ✓ 8) Bushy Park - Governor Russell requests that a full report of the Bushy Park project be given at the next meeting of the Board.






