But Michael Haley's transition home remains a work in progress, the couple told The State on Wednesday in an extended interview about his deployment.

"So when they come back, you have to transition back to either the old way or the new way and work it out together. It's not just the hug that you see when you get home. There's a few weeks of transition."

**Aiken Standard:** Award for small modular reactors not going to SRS

The Savannah River Site's goal of bringing small modular reactors to South Carolina has taken a significant blow now that a final award to fund the reactors is going toward a project based in Oregon. The Department of Energy announced it was giving the award to NuScale Power LLC in a release dated Dec. 12. Details must still be worked out, but funding will come from the \$452 million Small Modular Reactor Licensing Technical Support program. Small modular reactors – or SMRs – are defined as reactors with electricity outputs of less than 300 megawatts. They are said to allow for less on-site construction and increased containment efficiency.

**Note:** The announcement came about a week after Gov. Nikki Haley spoke with DOE Secretary Ernest Moniz during a visit to Washington, D.C. The two spoke about bringing the reactors to SRS.

The budget was passed in the second round of voting on Thursday after both Graham and U.S. Sen. Tim Scott, R-S.C., voted against it. The budget passing is a major step toward getting adequate funding for the Savannah River Site. Next, the bill will be submitted to President Barack Obama. After that, the Appropriations Committee will take the bill and divide the funding.

Veterans groups joined Sen. Lindsey Graham, R-Seneca, and others on Tuesday in Washington, D.C., to urge senators not to approve a budget deal that includes about \$6 billion in cuts to retirement benefits for military retirees. Graham will hold another news conference with the veterans' groups after the U.S. Senate is expected to vote on the budget deal today. The cuts, which the senators said in a letter would reduce cost-of-living benefits for "many military retirees under age 62" by one percent, were included in the budget deal passed last week by the U.S. House with bipartisan support, including votes from Assistant Democratic Leader Jim Clyburn, D-Columbia, and U.S. Reps. Joe Wilson, R-Springdale and Tom Rice, R-Myrtle Beach.

Columbia Mayor Steve Benjamin and a former city employee were among the targets in a public corruption probe that also involves South Carolina State University, a defense lawyer stated during a court proceeding Wednesday. Jim Griffin, an attorney who represents the university's former board chairman Jonathan Pinson, said in federal court in Charleston that wiretaps used to investigate alleged financial improprieties at a low-income housing development in Columbia jumped the track and snared Pinson and others for activity at S.C. A federal judge decided Wednesday that federal prosecutors can use wiretap evidence in the public corruption trial of former South Carolina State University Board Chairman Jonathan Pinson despite claims the evidence was wrongfully collected in an investigation of Columbia officials. U.S. District Judge David Norton ruled Wednesday FBI wiretaps against Pinson were gathered legally and were conducted in an "objectively reasonable fashion." Norton also denied a motion by Pinson's attorney to have racketeering charges dismissed. In addition, Norton denied a motion by co-defendant Eric Robinson to be tried separately from Pinson.

A consortium of four S.C. public school districts will receive \$25 million in federal Race to the Top grants -- one of five grant winners receiving about \$120 million. Clarendon 2, Orangeburg Consolidated 5, Richland 2 and Williamsburg are among 31 finalists for the grants from 80 school districts in 21 states. The U.S. Department of Education received more than 200 applications. The winners were chosen because of innovations that "tailor education for all students and provide school leaders and teachers with key tools that support them in meeting students' needs," according to a U.S. Education Department news release.

The Federal Reserve has sent its strongest vote of confidence in the U.S. economy since the Great Recession struck six years ago: It's decided the economy is finally strong enough to withstand a slight pullback in the Fed's stimulus. Yet the Fed also made clear it's hardly withdrawing its support for an economy that remains below full health. Chairman Ben Bernanke stressed at a news conference that the Fed would still work to keep borrowing rates low to try to spur spending and growth and increase very low inflation.
