### Governor Nikki Haley News:

With Iowa and New Hampshire soon in the rearview mirror, the Republican presidential race will shift to South Carolina. Larger and more diverse than the first two presidential contests, the state has a number of important constituencies in a Republican primary, including a large population of evangelicals, military veterans, retirees, professionals and working-class voters.

**Note:** Republican Gov. Nikki Haley said that she credits Mr. Trump with bringing excitement to the contest, but she has been critical of some of his rhetoric.

**Note:** "I have a great respect for the way Trump has gotten people excited," Ms. Haley said. "Whatever people think about Trump, to have the highest voter turnout ever in Iowa? You have to give him credit."

One of the most unconventional and unpredictable presidential campaigns in modern U.S. history descended Wednesday on South Carolina, gearing up to test the state's near-perfect record for picking eventual Republican winners. "South Carolina usually corrects the mistakes from the first two states," joked Katon Dawson, a former South Carolina Republican Party chairman.

**Note:** Adding intrigue is potential conflict between Trump and second-term Governor Nikki Haley, a hugely popular figure among South Carolina's GOP voters. She has been critical of the billionaire's hard-line stance on immigration and has decried what she called the "angriest voices" in her party.

**Note:** Haley, who endorsed Romney four years ago, is often mentioned as a potential vice presidential running mate.

A panel of Statehouse lawmakers has approved a preliminary proposal to forgive the repayment of South Carolina State University's \$12 million bailout loan. The S.C. House's budget-writing Higher Education and Technical Colleges Subcommittee approved a proposal that calls for forgiving the loan given to the state's only historically black public university in 2014.

**Note:** Gov. Nikki Haley vehemently opposed the bailout then as a member of the Budget and Control Board. She argued that the state was just giving "the money away because they know it can't be paid back."

### President's Executive Budget Defunds MOX:

**The State:** Obama plans to scrap MOX plant; SC leaders livid

The U.S. Department of Energy plans to abandon construction of a multi-billion dollar nuclear fuel factory at the Savannah River Site as costs rise and questions abound over the need for the facility. In the DOE's budget proposal for next year, the department says the mixed oxide fuel factory will be "terminated" beginning in fiscal year 2017, which starts in October.

**Note:** Meanwhile, Attorney General Wilson, the son of U.S. Rep. Wilson, filed suit Tuesday in federal court at the request of Gov. Nikki Haley.

**Note:** Haley, also a booster of the MOX plant, had previously threatened to sue the Department of Energy for its failure to meet a Jan. 1 deadline to begin removing the plutonium from the state if the plant wasn't built. She asked Wilson to take legal steps and collect a \$1 million daily fine, spelled out in federal law, because the plant is not completed.

South Carolina has again sued the federal government over an unfinished project to convert nuclear weapons components into reactor fuel, saying in a lawsuit filed Tuesday that the administration has acted unconstitutionally in failing to complete the mixed-oxide facility by a Jan. 1 deadline.

**Note:** The lawsuit has been expected. Last month, Gov. Nikki Haley told Wilson that she wanted to sue, also warning Energy Secretary Ernest Moniz in December that the state would be forced to sue if his agency didn't start making payments.

S.C. Attorney General Alan Wilson has filed a lawsuit to force the U.S. Department of Energy to finish the mixed oxide fuel fabrication, or MOX, project at the Savannah River Site, the same day President Barack Obama submitted his final federal budget proposal to Congress calling for the program's termination.

**Note:** Wilson threatened to sue at the end of 2015 at the urging of Gov. Nikki Haley.
