THE VICTIM, MELBA CARTER STATED TO CAPTAIN MARSH THAT WHEN SHE WENT TO CHECK HER MAIL SHE FOUND A YELLOW ENVELOPE WITH (2).44 CENTS STAMPS. THE ENVELOPE HAD NOT WENT THRU THE POSTAL OFFICE BECAUSE MELBA STATED THAT IN THE LETTER...

After Melba Carter had admitted, per a Chester County Sheriff's report which is attached, that she had taken the nude photo of me in my residence without my knowledge, she brought her 2 children, Cody and Whitney, to Chester County court. She had instructed her 2 children to lie in court. They testified that I would often come to their property during the night and drive around there home. They lied to cover up the crime their mother had committed. When they testified Cody was a minor but Whitney was of legal age. Both are of legal age now and can be questioned without a parent present.

Two days after Melba Carter came to my home and came on to me sexually by offering oral sex and took the nude photo of me without my knowledge, Shaw Nuclear/Shaw Group was using the nude photo as leverage in an attempt to get me to keep quiet about the inability to cyber secure the nuclear plants and not publish the manuscript. It is obvious Melba was paid by Shaw Nuclear to commit this act.

Melba Carter should have been arrest and prosecuted for multiple criminal infractions including a serious sex crime, filing multiple false police reports, suborning perjury, filing false insurance claims. Whitney Carter, her daughter, should be arrested and prosecuted for perjury. Cody is of legal age and if he is questioned, using the element of surprise as an interrogation tool, he will fold and tell the truth.

Melba Carter's sister, Vivian Carter, who is also the next door neighbor, will testify that they had planned to lie in court. Cody has been banned from Vivian's home because he perpetrated a 'breaking & entering' at Vivian's home and stole money. Cody is a suspect in other burglary acts in and around the Yarbrough Road community of rural Chester County.
