Attached are my redlined edits to version 3. I'm sorry that my edits just crossed in the mail with yours; I was already well into this when I saw Thad's message to the Experian guys about no. 4, so I just kept going. I'll review no. 4 now.

In addition, I have a question.

I think this part is confusing and might unintentionally cause someone to draw the wrong conclusion:

Q: How do I enroll a minor with ProtectMyID™?

A:

- Step One: A minor's parent or guardian must first enroll with ProtectMyID™. **It does not matter whether the minor is a dependent of the parent or guardian for tax purposes** – either parent or guardian may enroll the minor.

The highlighted part is my problem. I believe the intention is to say that either parent, regardless of which filed the returns and claimed the minor as a dependent, may enroll a minor who was named as a dependent.

But I believe it's possible that someone could construe the language to mean that a minor child who is not claimed as a dependent can be enrolled in the family plan, when the program as I understand it is designed to make the family plan available to those SC taxpayers whose minor dependents' SSNs may have been exposed. In other words, the minor must be dependent of one or the other parent for tax purposes.
