Dear AimHelp,

In review of the Older Americans Act: Programs, Funding, and 2006 Reauthorization (P.L. 109-365) it appears that Title III funds can be used for Supportive Services and Centers which is inclusive of adult day care services. In review of the South Carolina's Aging Network's Policies and Procedures Manual, adult day care appears to be an eligible activity under Title III-B funding and Title III-E funding. Historically, Title III-B funding has been allowed for adult day care services. The Newberry Council on Aging is requesting to continue using this funding. Please clarify information listed in Chapter 500 page 24 of the South Carolina's Aging Network's Policies and Procedures Manual.

Based on the information as shown we respectfully request that the following activities be added to the AIM software:

- Newberry COA - Adult Day Care for Fairfield clients- funding Title IIIB
- Newberry COA - Adult Day Care for Fairfield clients- funding HCBS
- Newberry COA - Adult Day Care for Lexington clients- funding Title IIIB
- Newberry COA - Adult Day Care for Lexington clients- funding HCBS
- Newberry COA - Adult Day Care for Newberry clients- funding Title IIIB
- Newberry COA - Adult Day Care for Newberry clients- funding HCBS
