**Outages Update:**

Duke Energy had a high of 27,000 outages yesterday, and still has 8,000 outages as of this morning in the Upstate (Greenville, Spartanburg, Anderson, Pickens, etc.). The crews have all the resources they need and were able to make good progress overnight, even with the continuing high winds.

**Forecast Update:** The weather service continues to cancel the various advisories across the state with some advisories remaining in effect until later tonight. However, EMD believes the worst appears to be over.

**Counties:** Darlington was the third county to decide to dismiss government offices early today. There are no requests for state assistance.

**Outages:** We have outage reports from SCE&G at 14,437, the CO-OPs at 9,367, and Duke at 29,965 – totaling 53,765 outages statewide. ORS is aware and monitoring the issue.

**Damage:** There are reports of some trees down and a report in Greenwood that two trailers were damaged because of this.

**NWS Advisories:**

- Tornado Watch (could occur) is in effect for Allendale this morning.
- Severe Thunderstorm Warning (occurring or about to occur) in effect for Aiken and Allendale all day.
- Flash Flood Watch (could occur) in effect for Upstate counties.

Forecast Effects: The additional quick-falling, torrential rainfall will hit grounds that are saturated and have not dried out since October. The high wind gusts are expected to bring down trees and cause power outages.

School Early Dismissals: Horry, Georgetown, Williamsburg, Dorchester, and Florence will have early dismissals today due to the weather. Charleston already has pre-scheduled half-day today, which was not weather related.

County Actions: No county offices are closed. Three counties have moved to OPCON 4 in support of observing today's weather conditions: Horry, Georgetown, and Marion. The EOCs will not be activated, but staff will be ready to support any storm response efforts.

State Action: EMD will continue to observe conditions and stand ready to assist counties if needed.

Feedback from Randy and Sam:

The rationale to dismiss early is due to concerns with the height of the school buses in the high wind, possibly tipping over or swerving on the road. The counties do not plan to close offices early, and therefore we do not expect state offices to close early either.

Expect a general update tomorrow afternoon/evening if there are requests for state assistance or significant damages.

The Horry and Georgetown schools have decided to dismiss early tomorrow due to the tornado threat, severe thunderstorms, and 45 mph wind gusts forecast for tomorrow afternoon. This seems unusual, because the forecast does not appear to warrant closures. Accordingly, Kim Stenson is touching base with the county emergency managers (Randy Webster in Horry, and Sam Hodge in Georgetown).

Expect another update later tonight or early in the morning.
