M I N U T E S

Mr. Poore called the meeting to order and Councilman Hooper gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted 3 in favor and 2 against funding the Association for Retarded Citizens \$10,000 from account #910 (Contingency Fund) and to fund the Detoxification Center (Anderson County Alcohol and Drug Abuse Commission) \$5,000 from the same account. Mr. Wright and Mr. Gerrard voted against the motion.

Mr. David Watson, Purchasing Agent, presented sealed bids for Pramital 25E weed and grass killer for the road maintenance department. Mr. Watson explained the bids in which FCX Company was the lowest with \$8.77 per gallon for a grand total of \$4,560.00. On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to purchase the Pramital 25E from FCX.

Mr. David Watson presented Council with sealed bids for asphalt to be picked up for road paving and patching. On the motion of Mr. Wright, seconded by Mr. Hooper, to award the bid to both Tribble and Pickens Construction Companies for \$22.25 per ton amended by Mr. Wiles, seconded by Mr. Hooper, to include the escalation clause that Pickens Construction Company may inform us of us of any escalation during the period July 1, 1980 thru September 30, 1980. Motion passed as amended by unanimous vote.

Mr. Robert Gamble speaking for the Youth Treatment Center asked Council to reconsider the Youth Home's request for funding. Council received as information.

Mr. Bill Moorehead, Vice-President of the Association for Retarded Citizens thanked Council for the action that was taken to fund \$10,000 which was the Associations' original request.

Mr. Poore recommended to recess until 12 noon and meet at his office at that hour to go into executive session. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted 4 in favor and 1 against to recess until 12 noon. Mr. Wiles voted against the motion. At 12:00 all County Council members appeared in Mr. Poore's office with the news media, Paul Brown, and news media for Greenville News. Mr. Poore advised Paul Brown that Council needed to discuss the articles of agreement concerning the Bailes Building. Council went into executive session signed the articles of agreement concerning the Bailes Building, voted to name a road off Hwy. 29 North after Danny Bannister, and voted to pay the sum of \$2,500.00 to attorney David Ross Clark to collect back taxes from Williamston Pants Plant.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to come out of executive session at 12:40 p.m. Council was unable to locate news media, proceeded into public session at which time the motions made in executive session were approved ~~once~~ again.
