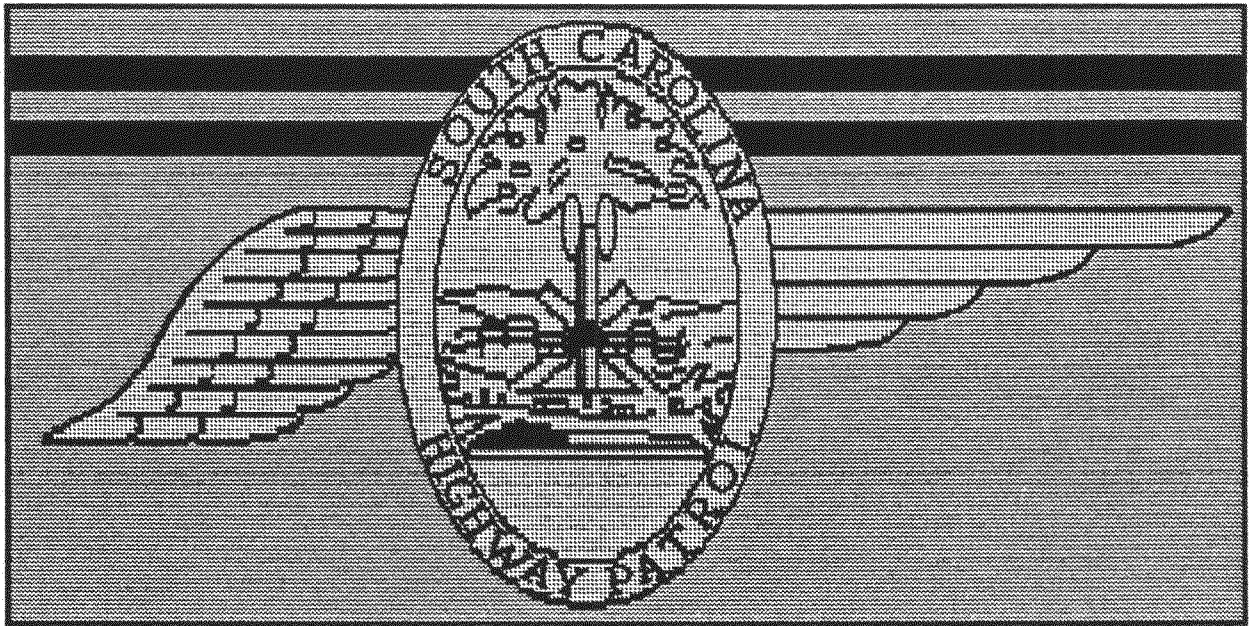

INTRODUCTION

The South Carolina Department of Highways and Public Transportation is the fifth largest state transportation department in the nation in terms of highway miles patrolled and maintained.

If the current and future level of traffic law enforcement and services are to continue, the Department must recognize and act upon critical existing issues; coupled with establishing and developing plans to enhance a more functional, effective, efficient operation within the Law Enforcement Division. Our immediate primary effort is directed toward a reorganization. The organizational structure of the Law Enforcement Division must first adequately meet the needs of the Division itself so that the services required can be performed in an efficient and effective manner. We must meet the needs required to insure safe highway travel.

The South Carolina Highway Patrol has long been noted for the excellent quality of law enforcement services rendered to citizens who use the streets and highways of South Carolina, therefore, in order to continue providing quality law enforcement services it is necessary that the Law Enforcement Division adopt an organizational structure that would better enable the division to deal with the current issues and to efficiently implement goals and objectives that have been established in regards to law enforcement services to the motoring public.

PRESENT STRUCTURE

In recent years the South Carolina Highway Patrol has operated under a structure that involved delegation of responsibilities to three people on the command level. This level consisted of approximately 850-900 uniformed officers. Since that time, the South Carolina Highway Patrol has grown in numbers, merely because of the demand for a more efficient and effective traffic enforcement program. This was coupled by the growing numbers of automobiles traveling on our highways each day. Supervision of patrol personnel in delegating responsibilities was adequate at the time. However, since the number of uniformed officers will grow in numbers the Highway Patrol has reached a saturation point of communication techniques being developed fully from the command level to the district level and filtering into the line officers responsibilities.

The South Carolina Highway Patrol is constantly striving to meet its primary objective in a rapidly changing law enforcement environment. The responsibilities of the Patrol are huge, with the most important being to provide sound, fair, and effective traffic law enforcement to ensure the welfare and safety of all South Carolinians and other travelers. Increased interstate, primary and secondary road mileage, traffic volume, commercial truck traffic and population growth all add to the growing responsibility being placed on the Highway Patrol. In order to meet the present and future demands for services, the Highway Patrol has developed an organizational structure that will provide the framework upon which a more effective and efficient law enforcement division can be conducted.

MISSION STATEMENT

The South Carolina Highway Patrol was created in 1930 with the primary objective to promote safe driving on our State's highways. This primary objective has and will be met in the future.

The overall responsibility is to insure that this safety exists in a uniform manner and create an atmosphere of professionalism by the troopers of this State in meeting the professional standards set forth by this method. The Patrol's responsibility is also to insure a safe and uniformed enforcement of motor vehicle traffic laws and aid in the reduction of fatalities and injuries.

AUTHORITY AND RESPONSIBILITY

Section 56-3-610 of the 1978 Code of Laws as amended gives the South Carolina Highway Patrol the responsibility for the enforcement of all Motor Vehicle laws relating to Traffic, Drivers License, Size and Weight, Motor Vehicle Dealers, Transportation of Illegal Drugs, Crowd Control, Highway Safety Administration and assisting all other law enforcement agencies upon request.

PROPOSED RANK STRUCTURE - S. C. HIGHWAY PATROL

Colonel - Director of Law Enforcement Division for the Department of Highways and Public Transportation.

Lt. Colonel - To assist the Director of the Law Enforcement Division in the day to day operation of the South Carolina Highway Patrol and to act in the Director's absence to insure that the proper command level supervision is administered.

Admin. Major - Responsible for all administrative functions related to the Law Enforcement Division of the Department of Highways and Public Transportation. Answers directly to the Assistant Director of the Law Enforcement Division.

Field Major - Answers directly to the Lt. Colonel and Colonel. Both Field Majors will be responsible for the enforcement operation in regards to one-half of the State at any given time and will be required to exchange zones on a periodic basis as deemed necessary by the Director of Law Enforcement.(Refer to enclosed state map denoting upper state and lower state zones.)

Field Major - Answers directly to the Lt. Colonel and Colonel. Both Field Majors will be responsible for the enforcement operation in regards to one-half of the State at any given time and will be required to exchange zones on a periodic basis as deemed necessary by the Director of Law Enforcement.(Refer to enclosed state map denoting upper state and lower state zones.)

Headquarters

Lieutenant - Assistant supervisor, serves directly under a Captain, also can be assigned specific duties that require independent decision making without conferring with next level supervisor.

First Sgt. - Responsible for county level supervision in counties with large populations, must have interstate route requiring 3 shifts and a total of 20 personnel assigned to county. Must hold the rank of sergeant to be eligible for this position.

Sergeant - Assistant to First Sergeant in large counties. Responsible for county supervision in smaller counties with no interstate highways and less than 20 personnel assigned to county. This position can be assigned to administrative duties that require special training and skills.

Corporal - Assists the County Sergeant with the supervision of personnel assigned to the county. Assumes the supervision duties in the absence of the Sergeant. This position may be assigned to administrative functions that require special training and skills.

Trooper 1/C - This rank is attained by completing 21 months of satisfactory service and being recommended by immediate supervisor.

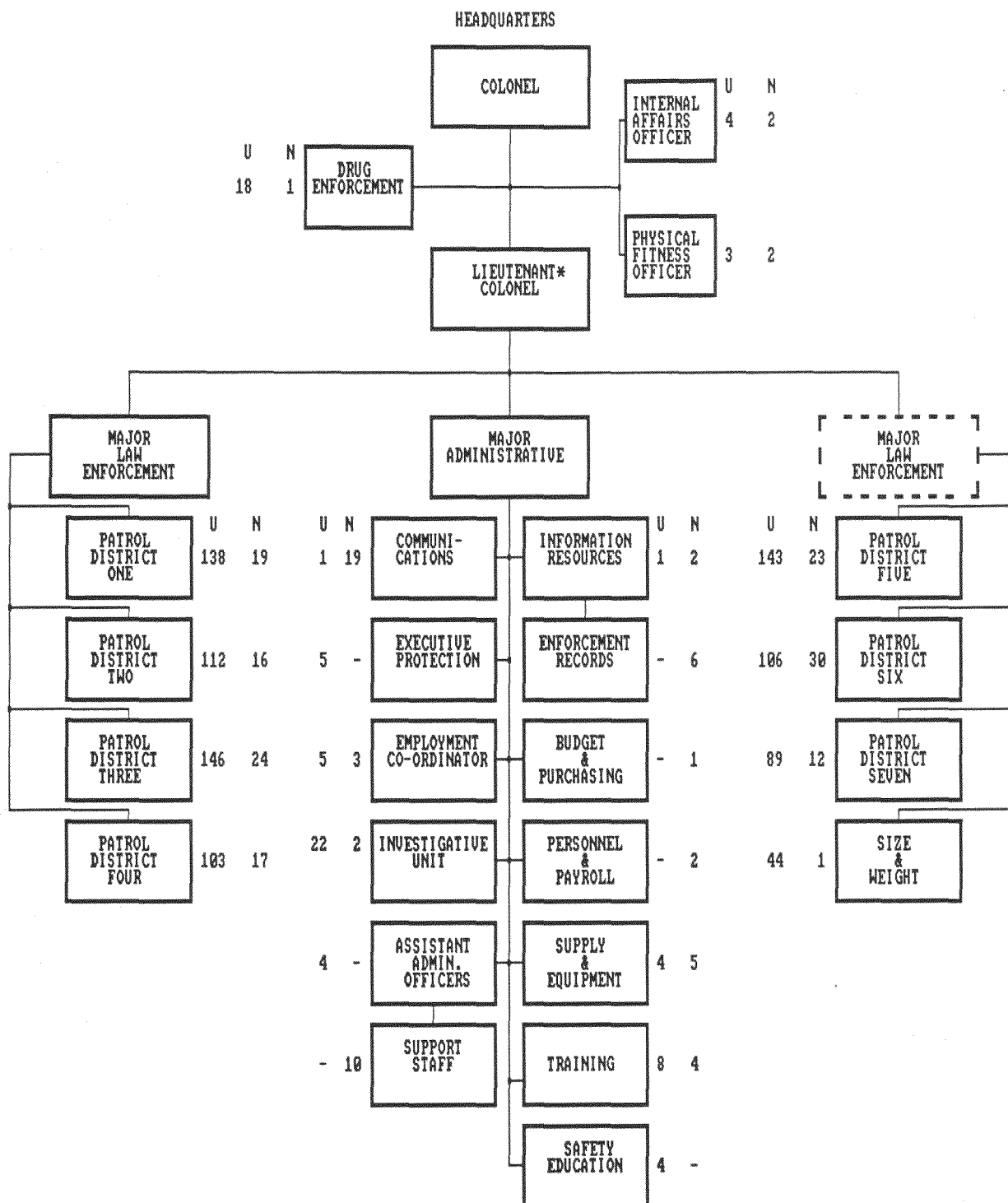
Trooper - Rank assigned to uniform employee who has satisfactorily completed patrol training school and has received commission.

The proposed change in the organization structure of the Highway Patrol is as follows:

- 1. To establish an additional Field Operations Major to respond to all field related traffic law enforcement and to be able to respond to any emergency situations that may develop at any given time in relationship to the zone assignment.*

PROGRAMS IMPLEMENTED BY THE HIGHWAY PATROL ARE AS FOLLOWS:

1. Routine patrol (40,000 miles of highways in rural and urban areas).
2. Selective enforcement program in areas where accidents are at a high volume.
3. Reduction of the transportation of illegal drugs (Governor's RAID Team).
4. Educating the motoring public in highway safety procedures (special programs, especially on holidays).
5. Provide quality training for all employees.
6. To provide training for entry level personnel (Basic recruit training).
7. Truck Size and Weight Enforcement (to minimize highway damage).
8. Special assignments for crowd control (ballgames, fairs, festivals and other, etc.).
9. Physical Fitness (Physical Fitness program to insure that each individual's good physical health is a necessity).
10. DUI Van Saturation(deterrent to drunken driving).
11. Management classes to insure that a smooth transition of supervision is carried to all levels.

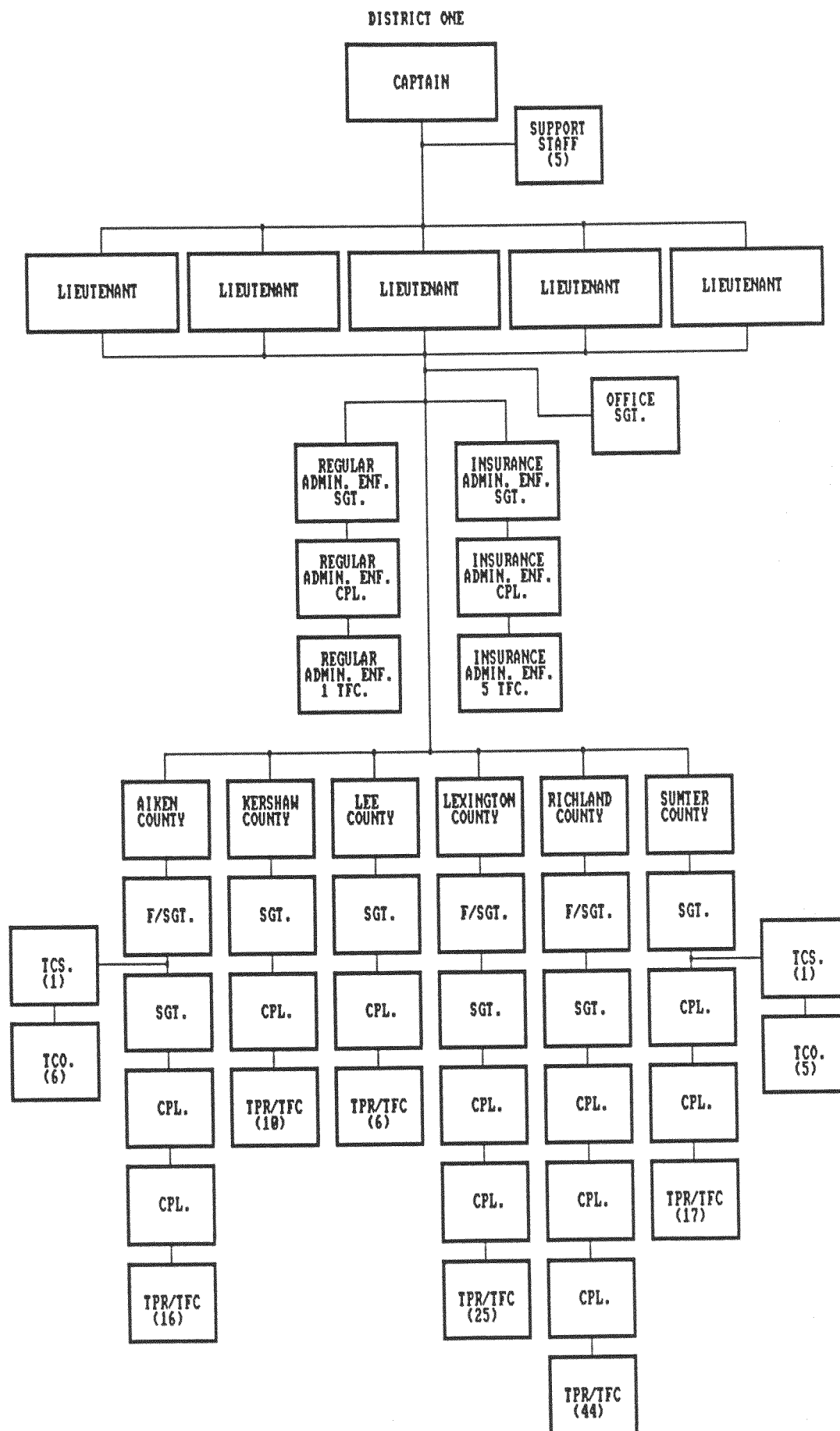

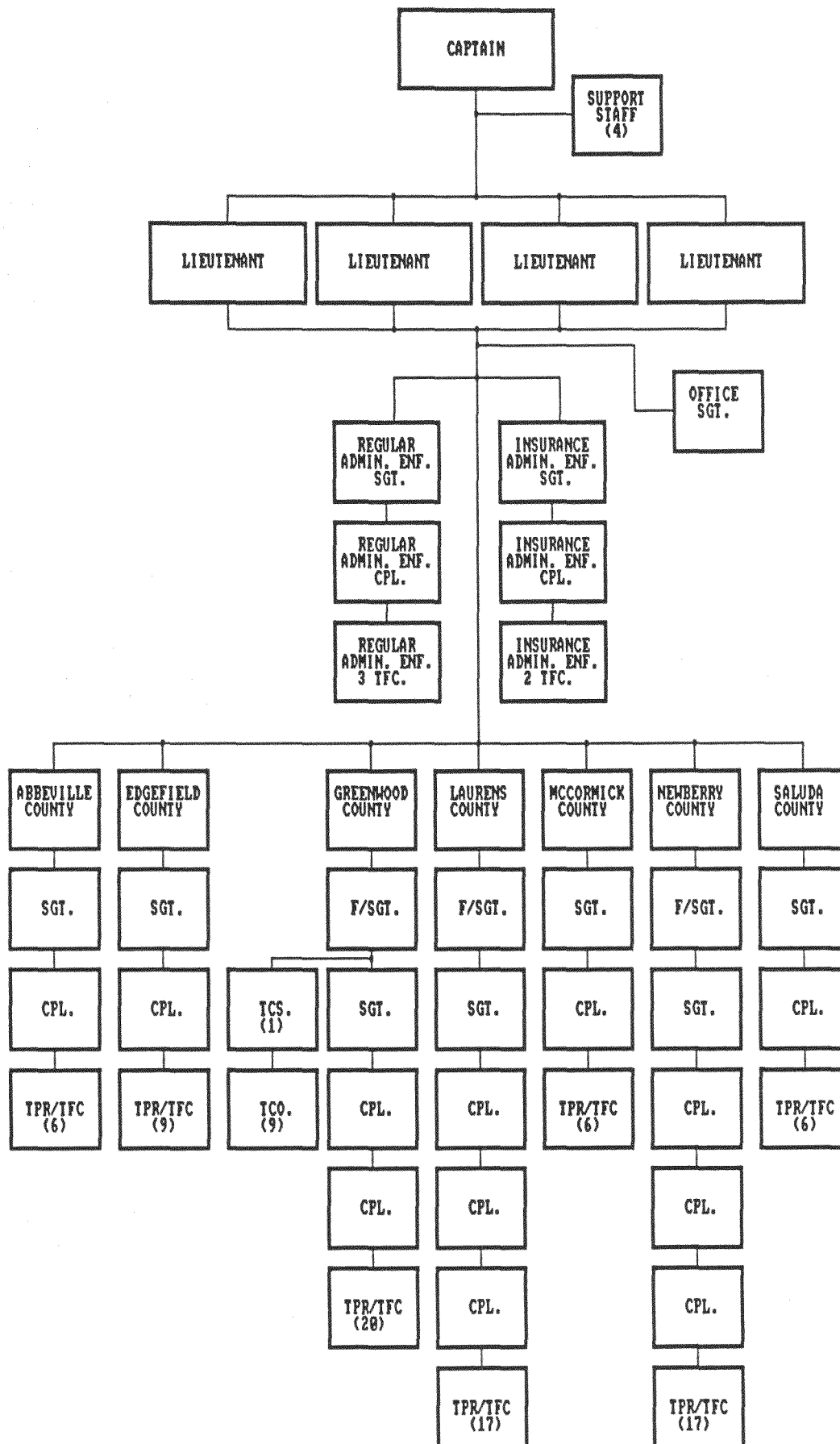

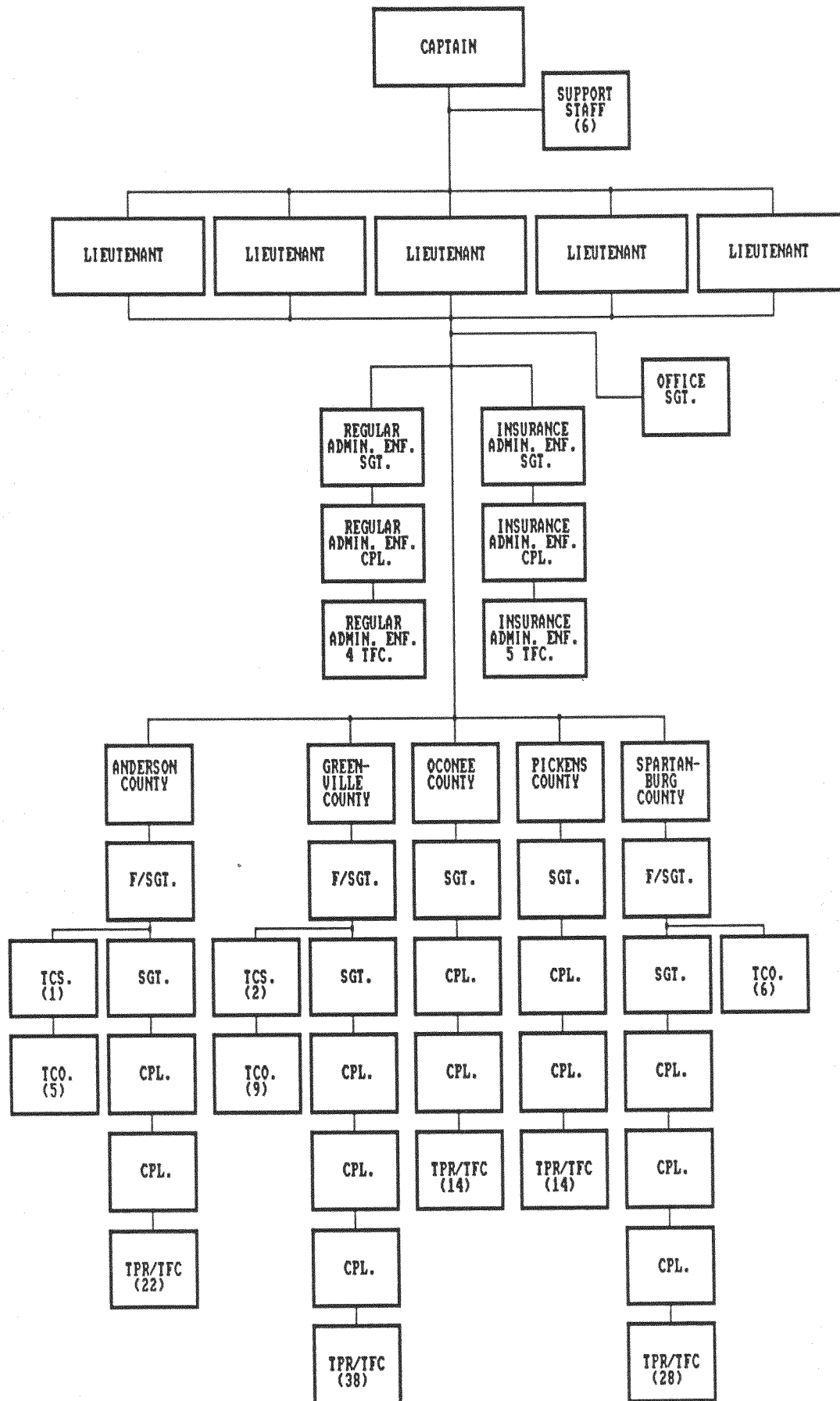

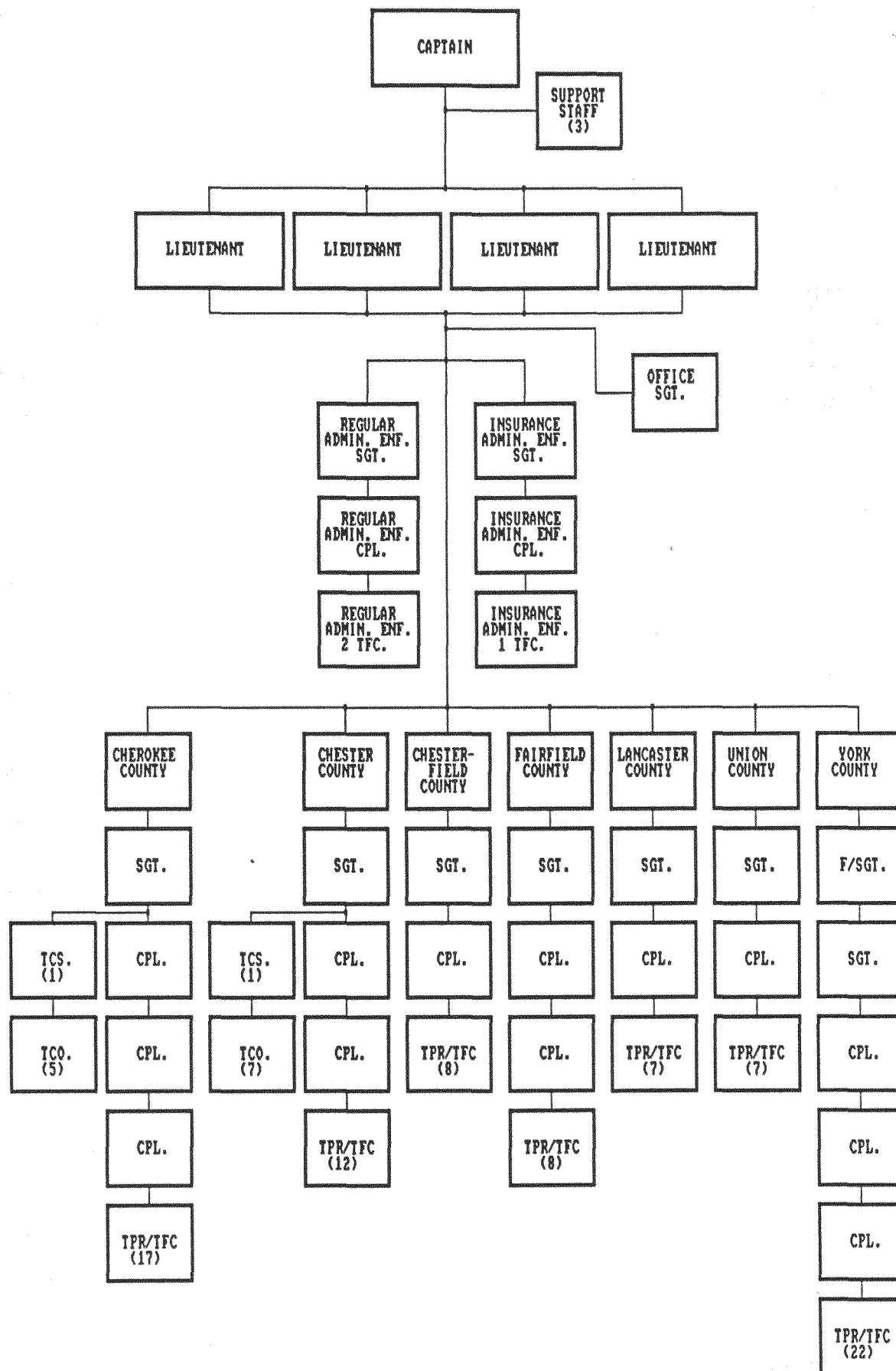

DISTRICT THREE



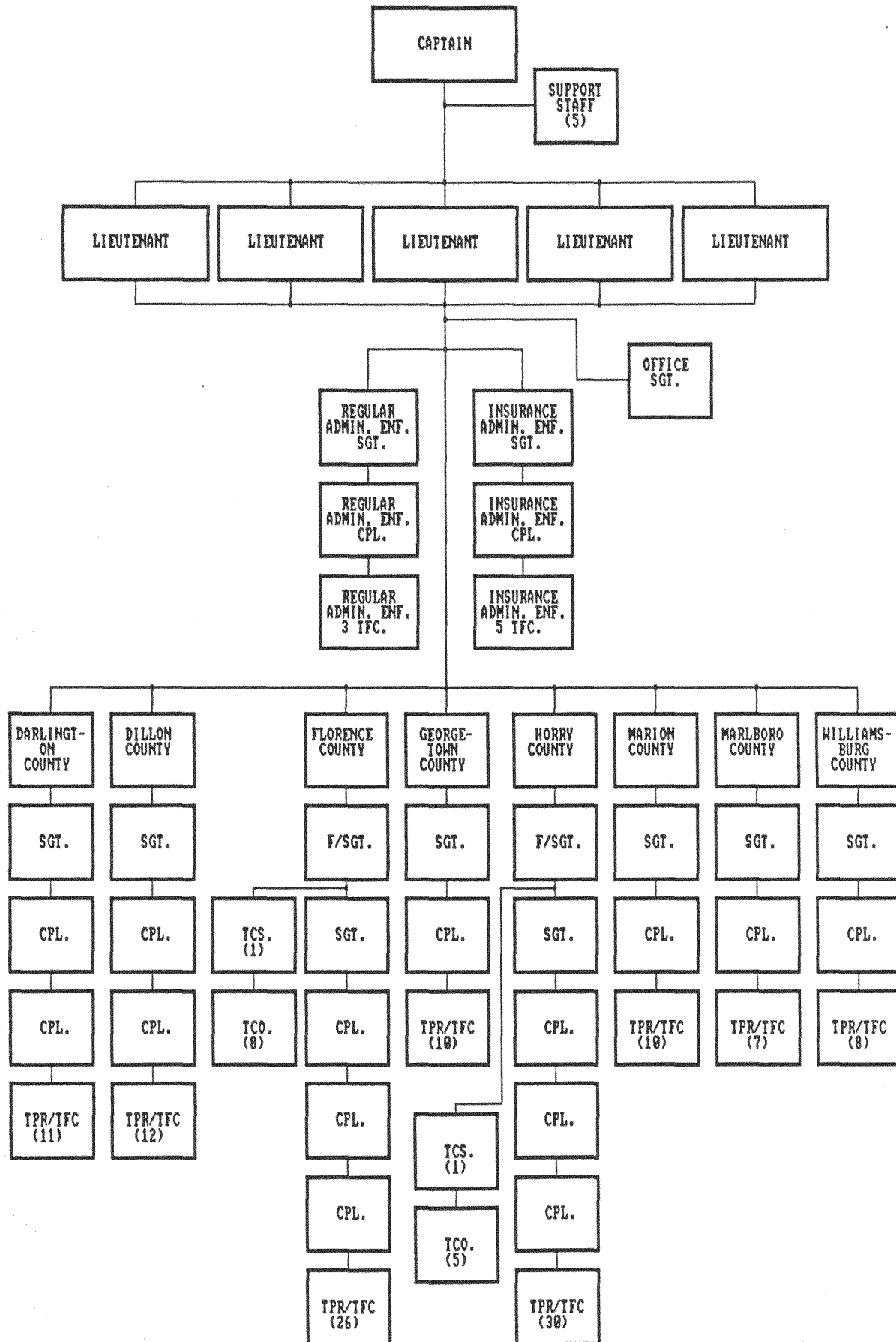

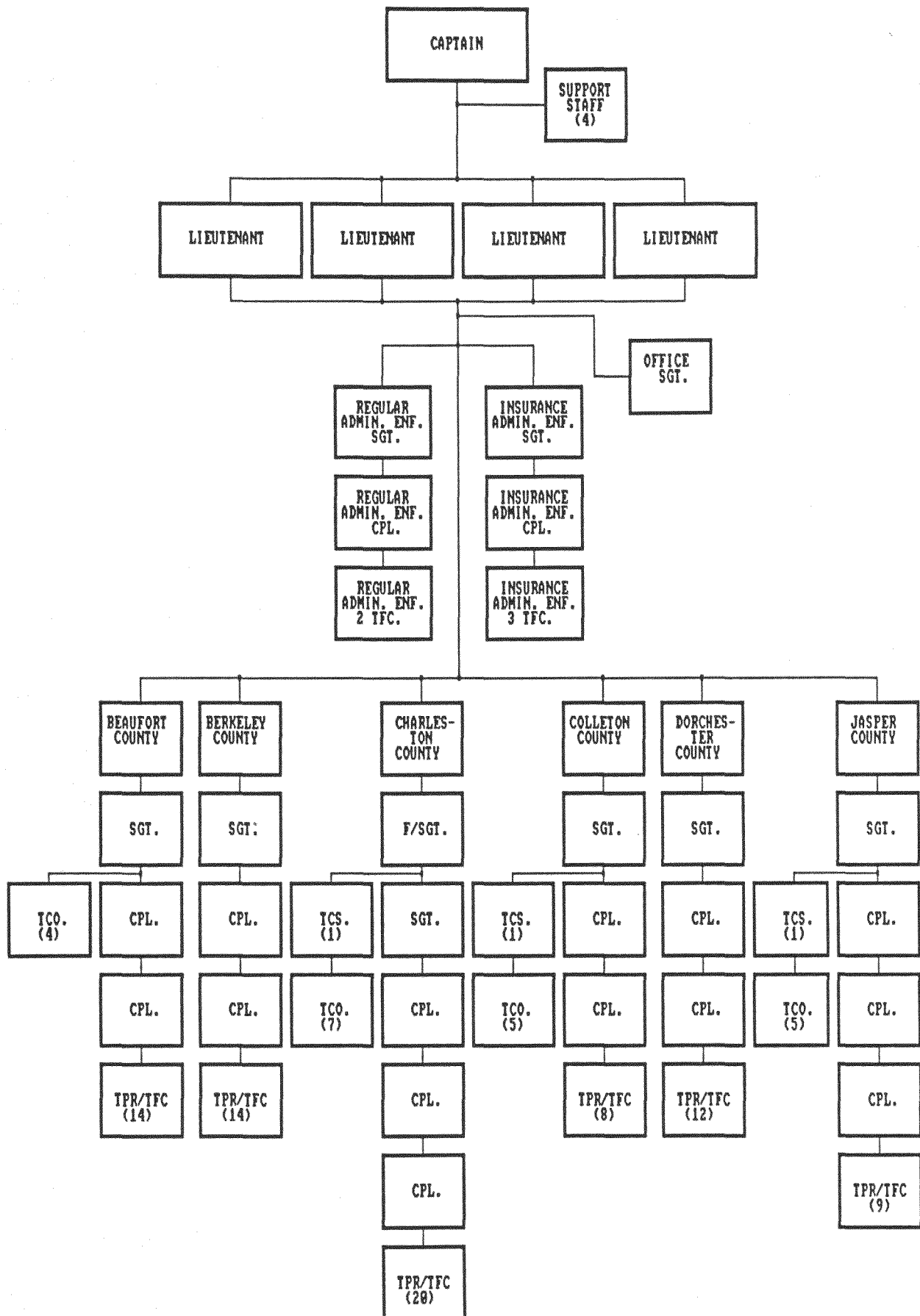

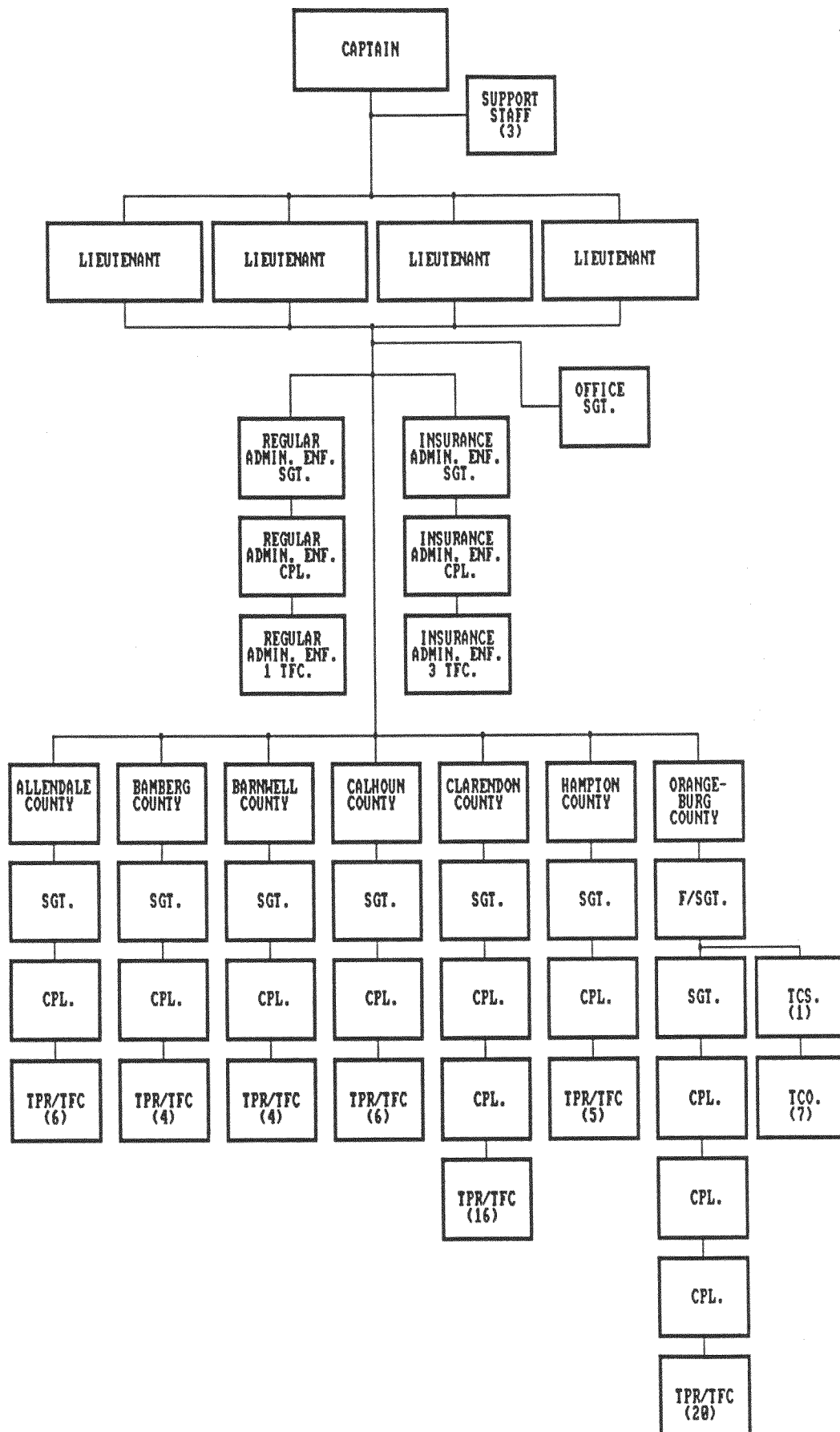

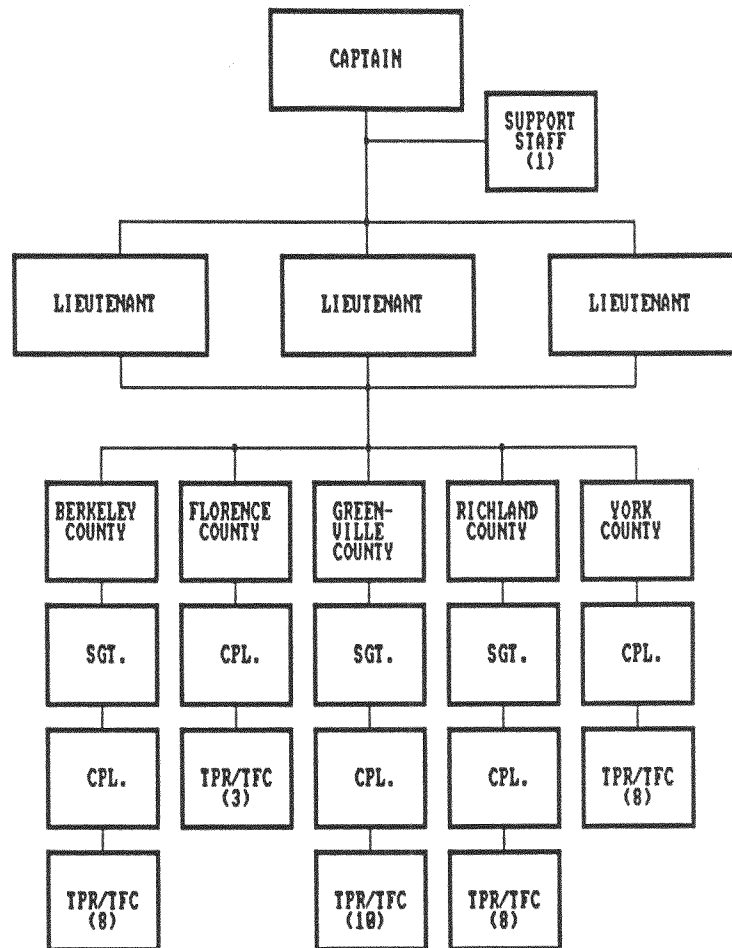

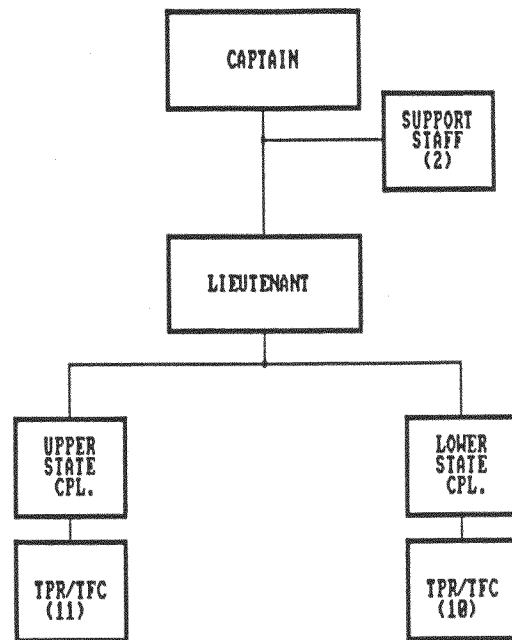

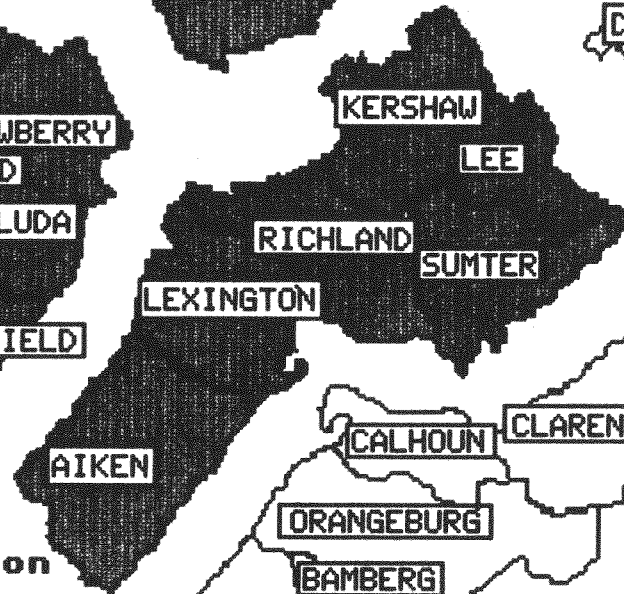

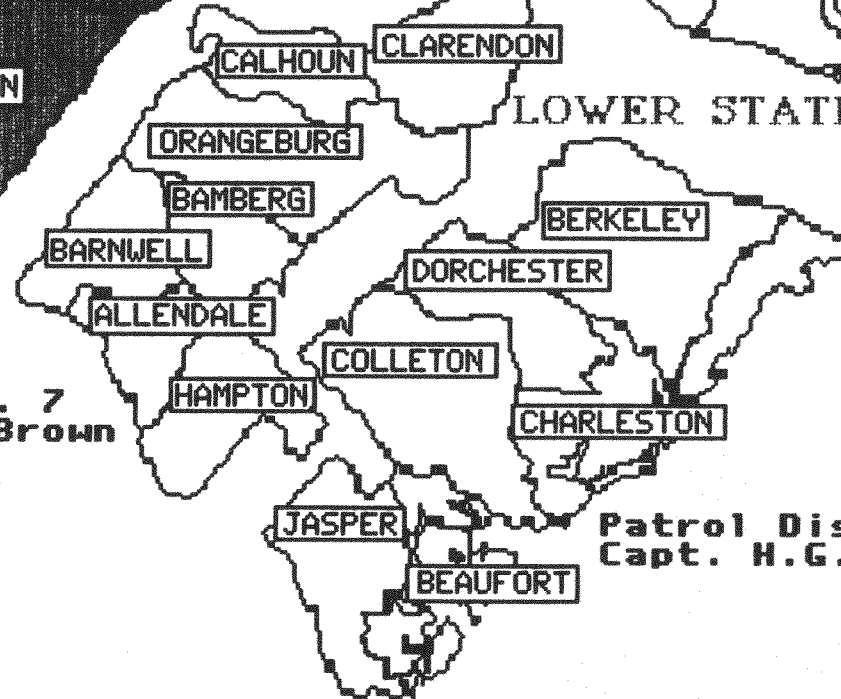
UPPER STATE - ZONE 1
