At a ribbon-cutting at a plant in Fountain Inn on Wednesday, South Carolina Gov. Nikki Haley called the Palmetto State the "it" place for manufacturing in the country. Haley helped open the new Bosch Rexroth manufacturing facility in the southern Greenville County city. The new facility is part of an \$80 million expansion project that will create 160 new jobs in the next five years. The expansion makes this facility the largest hydraulics production campus in the country.

**Note:** "To watch this expansion shows we're on the right track with manufacturing," Haley said. "The funnel is full, but when you get a good quality company like this that appreciates those that work for them, that tries to get the best quality project and takes care of their customers, South Carolina couldn't be more pleased."

German industrial conglomerate Robert Bosch GmbH, which employs about 4,000 people across South Carolina, will continue investing in the United States, where its business last year fared better than elsewhere around the world, a member of the company's management board said Wednesday in Fountain Inn. Werner Struth, who is also chairman of Bosch's extensive North American operations, was among the speakers during a ceremony marking the opening of an \$80 million, 160-job expansion of the Bosch Rexroth manufacturing complex in the Southchase industrial park off of Interstate 385.

Bosch Rexroth is working to recruit suppliers to locate near its Fountain Inn campus, company officials said Wednesday during the opening of its newly expanded hydraulics manufacturing campus. "Getting those suppliers closer saves them time and saves them money, so it's in everyone's best interest to get them here."

Calling it an "historic day," company officials along with Gov. Nikki Haley officially christened the newest addition to the growing Bosch Rexroth manufacturing campus in Fountain Inn on Wednesday. With around 200 people looking on, Haley and Bosch executives held a ceremonial ribbon cutting to mark the start of production in Building 103 — a former 260,000 square-foot industrial warehouse on the site that has been remodeled into a state-of-the-art production facility that will initially produce hydraulic pumps used in a variety of industries.

**Note:** "This truly is a celebration," Haley said. "What are we talking about? Eighty million dollars. The largest investment in North America. 160 new jobs right here in Fountain Inn. They could have done it anywhere else, but this is where they chose."

If a real estate agent who happens to be a legislator violates the law governing real estate agents, the Real Estate Commission, which is part of the Department of Labor, Licensing and Regulation, can fine him or suspend him or revoke his license, just like it would do to any other real estate agent. If a lawyer who happens to be a legislator steals money from her clients, the Supreme Court can reprimand or disbar her, just like it would any other lawyer.

**Note:** The two attorneys general for whom the commission is named agree with Mr. Simpkins' analysis, as did all of the members of the panel, which was appointed by Gov. Nikki Haley and unanimously recommended turning legislative enforcement of the law over to an independent commission by statute.
