### **What Must be Considered?**

Before settling refugees in a community we need to ascertain the capacity of social service agencies, child welfare agencies, child care facilities, educational facilities, health care facilities, translation and interpreter services, and law enforcement agencies to meet the existing needs of the community's current residents considering budgetary and other restraints. Specific issues to be considered:

- The capacity to provide medical care to refugees and their medical conditions.
- The capacity to provide affordable housing, low cost housing, or both, considering existing waiting lists.
- The capacity of the local school districts to meet the needs of the existing or anticipated refugee population, including education of unaccompanied refugee children and provision of English language training;
- The capacity of the economy in local areas to absorb new workers without displacing existing local workers.
- The capacity of state and local law enforcement to assure that law and order can be maintained and the citizens can be protected from crime.

In my view, this is a sensible and prudent process to ascertain all these factors before accepting foreign refugees.

Here's a Thought!

Let's consolidate the efforts of our religious groups and non-profits as well as other organizations to help the 50,000 American veterans who are homeless today in our country. Now, that would be true compassion shown to people who have given so much.
