We received the notice of violation for trash on our vacant property located at 2222 Harper Street and we sent our landscaping company to **once again** clean up the mess that the homeless and thugs are leaving behind. It seems to me that the City of Columbia should assign someone to hold the party /parties responsible for making the mess pay to clean it up. It seems the property owners are being hassled constantly yet nothing can be done to correct the cause of the problem. The City Council certainly seems to support the actions of the homeless, the gangs and the thugs that vandalize others people's properties by not doing anything to stop them.

I'm sure this is not your area however maybe you can direct me to the right person in higher ranks that can resolve this 6 month long battle that I am still fighting with no help of anyone at the City of Columbia PD. This is what I know to be true. In September, I filed a courtesy summons on a thug (Christopher Thomas) that has caused close to \$2000.00 in property damage to one of our rentals at 2440 Gordon Street. He has NO reason to be on the property. There have been several reports filed with CPD. I have been up there 4 times so far and have made several calls and have gotten no where.... I gave them his full name, where he hangs out, his address where he can be found, his phone number, even down to what he was wearing the day I went to the police department. I got the run around and sent back and forth between two building for over
