SECTION 1: The Minutes for October 20, 1994, copies of which were furnished to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 3: On motion of Commissioner Whitehead, duly seconded, the Commission unanimously passed a motion approving the Department's request to award a contract for repair of the Pine Island Bridge at Waccamaw in Horry County. This repair is being done as part of the settlement agreement reached with Horry County previously.

SECTION 4: On motion of Commissioner Whitehead, seconded by Commissioner Mullinax, the Commission unanimously passed a motion recommending the following requirements for cleaning and treatment of any mineral tile floor such as quarry, terrazzo, ceramic, spanish, glazed brick, granite and any other mineral tiles:

Apply a precise chemical formulation that will release dirt and oils from the pores of tile and concrete surfaces. The releasing action must restore the slip resistant of the original surface without the use of a coating or an acid. The dual releasing action must significantly increase the traction without damaging the appearance or the integrity of the floor surface.

All chemicals used in the initial treatment and routine maintenance must be Bio-Degradable and free of all acids and corrosive materials.

SECTION 5: There being no further business to come before the Commission the meeting was adjourned at 12:45 p.m.

SECTION 15: On motion of Commissioner Loftus, seconded by Commissioner Whitehead, the Commission unanimously passed a motion adopting the following resolution:

#### RESOLUTION

**WHEREAS,** the United States Congress in its passage of the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA) designated Route I-73 as a high priority route, and

**WHEREAS,** the location and designation of this route is left to the discretion of the various states in which the route is to be located, and

**WHEREAS,** it appears that the United State Congress will not authorize additional interstate mileage thereby prohibiting the construction of this road to interstate standards and making it more necessary to locate the route along an existing highway that can be upgraded as apart of the national highway system currently awaiting approval by Congress and

**WHEREAS,** the public and political acceptance of the Corridor location is divided among the various regions being Florence, the Grand Strand, and the area between the two, and

**WHEREAS,** economic benefit will be recognized regardless of which location is selected, existing and planned economic development must be served, and

**WHEREAS,** the metropolitan area connectivity from a point somewhere between the Grand Strand area and Florence appears to be more satisfactory, and

**WHEREAS,** the Commission has recognized the need for improved traffic flow in the Florence area by expediting the four-laning of U. S. Route 52 to better facilitate traffic demands in that corridor, and

**WHEREAS,** the Commission has also agreed to expedite the construction of the Conway Bypass which will facilitate traffic in and around the Grand Strand would appear to be more favorable, and

**WHEREAS**, from an environmental standpoint a location between Florence and the Grand Strand would appear to be more favorable, and

**WHEREAS**, utilizing the criteria to upgrade existing roads the estimated cost would favor a route that currently exists between the Grand Strand area and the Florence area, and

**WHEREAS**, traffic utilizing such a facility would be higher in the Grand Strand area as opposed to Florence or a mid-point area, and

**WHEREAS**, given all of the aforementioned factors, the South Carolina Department of Transportation Commission desires to designate this facility so as to serve the needs of the traveling public, contemplated industry, the economic well being of the State, and the citizens of South Carolina,

**BE IT RESOLVED**, the Commission of the South Carolina Department of Transportation hereby determines that I-73 within the borders of South Carolina will follow the corridor outlined below:

Beginning at and including the new Cooper River Bridge at Charleston, utilize US Route 17 to Georgetown, from Georgetown US Route 701 to Conway and from Conway follow the current location of US Route 501 including the Marion Bypass, and from Marion utilize SC Route 38 crossing I-95 in the vicinity of Oak Grove Community, continuing along Route 38 around or through the Towns of Brownsville and Blenheim to the Town of Bennettsville utilizing Route 9 and US Route 1, exiting South Carolina along US Route 1 near the Town of Wallace.

**SECTION 16:** On motion of Commissioner Loftus, duly seconded the Commission unanimously passed a motion that a copy of the I-73 resolution be forwarded to each member of the United States Senate from South Carolina, the South Carolina Congressional Delegation and to the state, regional and national offices of the Federal Highway Administration; and further that the federal grant of \$400,000.00 designated for this corridor study be used to determine what steps are necessary to upgrade the corridor selection to those standards that will fit this designation.

SECTION 17: On motion of Commissioner Mullinax, seconded by Commissioner Mack, the Commission unanimously passed a motion authorizing the Director and his staff to review the Greer South Parkway feasibility study and prepare the appropriate recommendations to the Appalachian Regional Commission for this project to be designated as an Appalachian Development Access Road.

SECTION 18: There being no further business to come before the Commission the meeting was adjourned at 12:30 p.m.

AGREEMENT WITH NORTH CAROLINA DEPARTMENT OF TRANSPORTATION

It is recommended that the SCDOT Commission authorize the DEPARTMENT (SCDOT) to provide funding to the North Carolina Department of Transportation as the state's contribution to participate in the development of a Southeastern High Speed Rail Corridor Study. The amount requested to be made available is \$25,000 to come from unobligated State Mass Transit Funds. 

The Clarendon County Transportation Committee requests that the South Carolina Department of Transportation to administer all funds made available to Clarendon County under the revised "C" Fund Law.


The Clarendon County Transportation Committee requests that all projects in Clarendon County that are under construction and/or programmed, but not yet let to contract, be advanced to completion.

There are thirty-four (34) miles of interstate roads, one hundred thirty four (134) miles of primary paved roads, six hundred thirty (630) miles of secondary paved roads and one hundred seventy three (173) bridges in Clarendon County maintained by the South Carolina Department of Transportation. Clarendon County maintains approximately six hundred fifty (650) miles of unpaved dirt roads and approximately five (5) miles of paved roads. All paved roads and streets in municipalities are maintained by the South Carolina Department of Transportation.

To develop our program for transmitting to the South Carolina Department of Transportation for implementation, the Clarendon County Transportation Committee will consider input from citizens of the county and county and municipal officials. The Clarendon County Transportation Committee may receive recommendations for resurfacing and bridge replacement needs from the South Carolina Department of Transportation. Consideration will be given to needs in municipalities and rural areas. Further, consideration will be given to resurfacing needs and new construction.

A rating system or criteria will be developed to aid in evaluating needs and setting priorities on individual roads. We realize that there may be emergencies or other specific needs such as industrial roads, school roads and recreational roads that may arise and be worthy of consideration.

The Clarendon County Transportation Committee will cooperate with other county transportation committees in adjacent counties when it is mutually beneficial to have transportation facilities cross county lines.
