Thank you for your recent message to Governor Haley's office regarding refugee resettlement. The refugee resettlement program is a federal program designed to provide comprehensive and uniform provisions for the effective resettlement and absorption of admitted refugees. Before entering the United States, refugees receive the highest level of security screening by both the United States Department of State and the United States Department of Homeland Security, including biometric and biographic checks. In South Carolina the Department of Social Services administers the federally funded program.
