Sharon,

In IIIB transportation, we will run out of IIIB funds during the month of February. To continue to serve IIIB transportation through June, we need an estimated additional **110,000 passenger miles x .64 per mile = \$70,400 IIIB total; Federal 85% = 59,840; State 5% = \$3,520; Local match = \$7,040**

I estimate we will still have 80 remaining on our Home-Delivered Meals waiting list after we get add some new folks in for a couple of grants we just received. From February through June, we would need **8,320 Meals**. At the **HCBS rate this would be \$51,334. At the IIC2 rate, this would be \$40,829 total; Federal 85% = \$34,705; State 5% = \$2,041; Local Match = \$4,083.**

We also currently have 20 folks on our Waiting list for Congregate Meals due to the lack of transportation funds. But we need to first make sure we can fund transportation for the people we are currently serving.
