Mr. McDonald, Stop ignoring the life threatening issues within the ASGDC. If you truly believe that "Black lives Matter", make a difference and correct the injustice's and human rights violations within this Slave Prison Camp!

Subject: Criminal Sexual Assault by William M. Yates, M.D.,

In responding to the Richland County's ever-deepening sexual abuse crises reflect a sickness that is not unique to the Richland County Council Officials. In fact, that sickness creeps into all professional communities of which I know, and leaves a trail of victims in its wake every time. I refer to the way in which Richland County Detention Center leaders and the communities which they lead wear the mantle of victimhood to cover their naked moral failings.

However, ugly such ranting is, it hardly compares to the ugliness of what happened to the victims in these cases, and the sluggish response, if not full out cover-up, by the Correct Care Solutions, Alvin S. Glenn Detention Center, Office of Disciplinary Council and specific members of County Council. Dr. William M. Yates MD and his leaders to portray themselves as the victims at this moment, is beyond reprehension, they have actually laid the groundwork for further past and present abuse.

I don't know what Dr. Yates should do, but I know that hiding behind the mantle of victimhood at moments such as these is what brings down communities and their sacred institutions. The "rock upon which the Physicians Oath is built" could crumble if the State Labor Licensing and Regulation, ODC, SLED, County Council and Alvin S. Glenn Detention Center officials don't figure that out soon. Innocent detention center victims fall prey to the same ugly institutional protectionism. All of which abets protecting abusive contracted physicians and attorney's instead of their unprotected innocent victims.

“People / Men don’t lie about being sexually assaulted.”

Whenever a person experiences sexual assault, the idea that they will not be believed often acts as a deterrent to seeking help. Additionally, victim or survivors of sexual assault are also often blamed for what has happened to them. Because of this, and other factors, people who have been sexually assaulted report less often and do not get the help they need at a time when they need it most. However, enough is enough! Being the victim of false arrest, yellow journalism, discriminating tactics, false accusations, dirty tricks and a strategic well orchestrated whisper campaign, is not uncommon in Richland County, South Carolina. The media falsely portrays those who commit sexual assault in a stereotypical way which influences how people form ideas around the issue. As a result, the general public is given the wrong impression of who is actually committing sexual assault. The majority of the people who commit sexual assault are everyday people who are married with children and have regular jobs. They are also college students, family members, co-workers, etc.

Their behavior is what makes them sexual predators not their lifestyles. This does not mean that rape is not committed by strangers; it does. Most victims/survivors of sexual assault know their perpetrators. This holds true in the case of the 18 year old innocent young lady, who became the victim of Dr. William M. Yates. Yates pleaded guilty for a past criminal conviction for sexual assault.

Ironically, Dr. Yates also holds a law license in the state of Massachusetts with a license to practice law in the State of South Carolina. Attorney Yates received a regulatory slap on the wrist following a conviction for using alcohol and drugs with an underage patient as part of a sex crime. Statistics provided by the states Supreme Court's Office of Lawyer Regulation show that in about 40% of the cases reviewed by the agency, lawyers who received only minor sanctions for violating discipline rules went on to reoffend. When drugs or alcohol are used to lower someone’s cognitive thinking skills or their ability to give consent to sexual activity that is rape. Often when a victim or survivor reports having been intoxicated or on drugs, their story is deemed “regret sex” or “they just had too much to drink.” Was that the case with this underage female victim of Dr. Yates? Why was he allowed to practice medicine & law again? Are non convicted inmates second class citizens?

Sexual assault and rape are traditionally thought to be a women’s issue; that women are the only ones who are and can be victimized; and that women are the ones who should end sexual assault. Unfortunately, men are victims and
