Report on Annual Evaluation of Two-Year
Programs in Public Institutions

The South Carolina Master Plan for Higher Education states that the Commission will annually review all programs leading to the associate degree. Data on enrollments, graduates, and placements are collected for all such programs which have been in existence for three or more years. The following minimum standards apply:

- 1) Degrees Conferred - At least six (6) students in the previous year or an average of six (6) students over the preceding three years will have graduated from each degree program. The number of graduates completing a program will be taken from the three most recent Commission on Higher Education survey forms for completion of HEGIS Report 2300-2.1 (Degrees and other Formal Awards Conferred).
- 2) Enrollments - Each two-year degree program, in the preceding fall quarter or semester, will have enrolled a minimum of 16 students (headcount) and generated a minimum of 12 full-time equivalents (F.T.E.). The number of headcount students enrolled in a program will be taken from the most recent HEGIS Report 2300-2.9 (Enrollment by Degree Field), or the most recent Fall Quarter TEC/AIDS Report. Full-time equivalents may be determined for this report by taking all full-time students plus one-third of the part-time students, using TEC/AIDS Reports, or using some other appropriate internal procedure.
- 3) Appropriate Employment or Continuation of Education - Follow-up of the most recent annual graduating class from each program will demonstrate that fifty percent (50%) of the graduates who are available for placement have found employment directly related to their educational program or are pursuing additional education full-time in a postsecondary institution. Placement or transfer data on the previous year's graduates will be obtained by a documented follow-up survey. In preparing placement or transfer data for the report, graduates who have died, become disabled, or chosen not to seek employment or transfer should be counted as "exclusions" and subtracted from the graduates before application of the fifty percent criterion.

Programs which fail to meet the above standards must be suspended or cancelled unless their continuation or continuation on probation is justified to the Commission in writing. Such justification must take into consideration such factors as manpower requirements, funding, and employment of "stop-outs." In addition, no program may be continued on probation or remain under suspension for more than three years.

During the spring and summer of 1982, 269 active associate degree programs in 28 institutions were evaluated. In addition, 12 programs remained in suspended status from the previous year, and three of 11 programs which had not been implemented were cancelled or suspended. Table 1 lists programs suspended or cancelled this year. Table 2 lists programs currently under a second or third year of suspension. Table 3 provides summary data on the status of the 269 active programs which were evaluated this year.

This is the second year that this evaluation process has been implemented for all two-year programs in public institutions; and the first year that all institutions were able to provide complete, useable data. Several institutions used the "Continued Justified" category for programs which they felt were failing to meet one or more criteria on a temporary basis. Since programs can remain in the "Continued Probation" category for up to three years, I suggest that we modify the instructions on next year's form to indicate that the "Continued Justified" category can only be used when programs are not expected to meet criteria for continuation within three years, but can still be justified for other appropriate reasons.

Recommendation:

We recommend that the Commission approve this report, including the actions summarized therein, and that instructions for next year's annual evaluation be modified to indicate that the "Continued Justified" category be limited to programs which are not expected to meet criteria for continuation within three years, but which can still be justified for other appropriate reasons.
