Dear Dr. Wells,

As we agreed through earlier communication, I am sending you the projected budget figures for the SCORxE Academic Detailing Service (SCORxE) January 2011 – June 2012 to show there are sufficient funds on board to support a contract renewal for FY12. I understand this renewal will include only a date extension and no additional funding. Amendments 4 and 5 to the current South Carolina Medicaid Academic Detailing Project (Number A8 1541 A) extended the date through June 30, 2011 (Amendment 4) and increased funding by \$747,559 (Amendment 5).

The table below includes a budget for calendar year 2011 and January – June 2012 that totals \$618,285. As of January 31st, 2011, SCORxE had a balance of \$623,694.

As a reminder, we also have funds coming into SCORxE as a stakeholder in the CHIPRA Quality Demonstration Grant through FY15. In addition, the SC Department of Health and Environmental Control Division of Tobacco Prevention and Control has been awarded funding from Centers for Disease Control and Prevention to help support delivery of the SCORxE topic on the promotion of smoking cessation. I continue to look for other sources of funding to sustain SCORxE beyond FY12.
