On June 30, 1939 The Housing Authority of the City
of Columbia, S.C. petitioned this Court for the appointment

of July 7, 1939, appointed R. E. Carwile, W. L. Bennett and

Thereafter, on August 4, 1939, a hearing was had
before the Condemnation Board, pursuant to notice, ~~which~~
~~at~~ at which time testimony was taken as to the value,
after which the Board, by its finding of August 4, 1939,

found that the fair value of the property to be taken was Two Hundred and Seventy (\$270.00) Dollars, notice of which was given to The Housing Authority of the City of Columbia, S.C.

On the 11th day of September, 1939, The Housing Authority of the City of Columbia, S.C., as will appear from the receipt of the Honl C. E. Hinnant, Clerk of this Court, deposited with this Court the sum of Two Hundred and Seventy (\$270.00) Dollars, representing the condemnation award in this matter, and on the same day gave notice to the Forfeited Land Commission of the said deposit and of the fact that pursuant to the statute title to the property at the time of the deposit passed to The Housing Authority of the City of Columbia, S.C., with the right on the part of that Authority to immediate possession.

In the same instrument The Housing Authority of the City of Columbia, S.C. gave notice that it would apply to this Court at the time set out in the notice for an order confirming its title to this property, and directing the Clerk of this Court to execute a proper deed to The Housing Authority of the City of Columbia, S.C. as evidence of its title, vesting in it all of the rights of the estate of Mary C. G. Popwell, W. S. Popwell and Jas. H. Popwell, and all other persons having any interest in the said property.



MR. W. H. GREEVER, JR., being first duly sworn, testified as follows:

BY MR. DREHER:

Q. Mr. Greever, will you tell the Board what your appraisal of No. 41 is, and how you arrived at it?

A. We appraised that property on January 30, 1939 for the Housing Authority and found the property measured 36 by 104. We ascribed a value of \$270.00 for the land and found no improvements on the property. The valuation was arrived at by comparing values of similar type properties in the area and we expressed that valuation on USHA Form #424.

Q. Is this your original appraisal?

A. Yes, sir.

Appraisal Sheet offered and received in evidence and marked Exhibit No. 1.

BY MR. Bellin: That is approximately \$7.50 a front foot. Did you value the corresponding property that had the same depth at that?

A. Yes, sir, relatively the same.
