Dr Burton,

It has recently come to my attention that Medicaid may be discontinuing coverage for Home Preterm Labor services. I want to let you how this would affect my practice and my patients. I am a Perinatologist specializing in high risk pregnancies and I deal with the problem of preterm labor on a regular basis. I have successfully utilized Home Monitoring, and the Terbutaline Pump, as an alternative to hospitalization for many years. This has been beneficial to both saving healthcare dollars as well as allowing my patients to be managed at home in a less stressful environment.

There was a time when these services were not an option for the Medicaid patient, and we found ourselves struggling with what to do with patients that needed extra nursing attention but did not need to be hospitalized. I have found that if the problem is identified early and the patient is tocolyzed appropriately, many of these pregnancies have been prolonged and we have seen improved outcomes.

I feel strongly that you would be limiting the management options and increasing hospitalizations if Medicaid decides to discontinue coverage. This population generally needs all the support we can provide them.

Thank you for corresponding to relate your concerns regarding South Carolina Department of Health and Human Services (SCDHHS) payment for Home Preterm Labor services. Let me assure you that there are no plans to discontinue this Agency's support for this care. Specifically, tocolysis and home nursing support are vital components of prenatal care for some high-risk pregnancies. SCDHHS has been reviewing the overall scope of these services, however, and are in discussions regarding the bundling or packaging of some of these items of care. We are working closely with the OB/Gyn physician community to assure that any further decisions will continue to offer providers of this care the support that is needed.
