THIS is a follow up to our conversation about DMV assisting us to identify persons who may be eligible for homestead exemption. What I would like to get is a listing of all drivers (or those with ID cards) born in 1940 or before. THIS information would be compared to our property owners and homestead recipients to determine if there may be some people who qualify for the homestead exemption but are not receiving it. This would be used only by our office and would not be shared with anyone outside of it. If this is something that DMV can help us with, Wayne Richardson can talk with Rolf Dolder (or whomever else) about the format for receiving the information.

Also, please let me know if there would be a cost for doing this. I would like to do this as soon as possible since the next few months is slow for us in our Homestead department.
