Less than three months before the kickoff Iowa caucuses, there is growing anxiety bordering on panic among Republican elites about the dominance and durability of Donald Trump and Ben Carson and widespread bewilderment over how to defeat them.

**Note:** South Carolina Gov. Nikki Haley, herself an outsider who rode the tea party wave into office five years ago, explained the phenomenon. “You have a lot of people who were told that if we got a majority in the House and a majority in the Senate, then life was gonna be great,” she said in an interview Thursday. “What you’re seeing is that people are angry. Where’s the change? Why aren’t there bills on the president’s desk every day for him to veto? They’re saying, ‘Look, what you said would happen didn’t happen, so we’re going to go with anyone who hasn’t been elected.’”

A federal judge has delayed the trial for a defendant accused of not telling everything he knew about the plans of a man charged with shooting nine black parishioners at a Charleston church. U.S. District Judge Richard Gergel agreed Friday to postpone the trial of 21-year-old Joey Meek until at least March. No trial date was set.
