David:

In reply to your previous question, the PRM report which shows refugee arrivals to SC by fiscal year is accurate. After talking to LIRS, it appears that the second report you attached summarizes a raw spreadsheet of working data provided by Lutheran Services in Columbia, the local resettlement affiliate. This spreadsheet included data on not just refugee arrivals, but also refugees who in-migrated to the state, refugee cases which were transferred to other locations, asylees, and even some duplication of numbers due to different programs in which refugees enrolled. Additionally, the Lutheran Services' data combined some fiscal years. Please know it is a requirement for every resettlement agency to reconcile their arrival numbers with those held at the refugee processing center, which is where the report we sent to you was generated.

We are working up the report formats noted in the McDonough letter and hope to have those ready in the next two weeks. As soon as those are ready I'll reply to you so SC can receive that information.
