DIVISION OF MOTOR VEHICLES PROCEDURAL MEMORANDUM NO. 97-404

Subject: Special License Plates

Attached is a list of the license plates issued by the Department. Listed for each special plate is the statute number authorizing the license plate, the fees and the special requirements, if any, to obtain each different type plate.

The following are requirements which must be met for a special license plate to be issued for the first time regardless of the type.

1. A completed and signed insurance certification form.
2. Paid property tax receipt or MCTG record reflecting personal property taxes paid through the expiration date of the decal on the license plate being issued. If there is no change in the expiration dates, a property tax receipt is not required.
3. If the statute authorizes a special plate fee, no credit or refund is available for this fee. Portions of the special plate fees are disbursed into accounts for distribution to other entities.
