SUBJECT: Notice of Grant Opportunity for Law Enforcement

Dear Law Enforcement Agencies:

The Lieutenant Governor's Office on Aging is proud to announce a grant opportunity to provide law enforcement agencies (LEA) with Drug Take Back Boxes beginning on November 21st, 2017. We have worked with the South Carolina Sheriffs Association, South Carolina Police Chiefs Association, and South Carolina Law Enforcement Officers Association to organize this assistance.

South Carolina is experiencing an evolving opioid crisis which is effecting everyone, including seniors. Seniors are unique in that while they are often over prescribed and in some cases abusing opioids, they are also frequently in possession of unused prescription medication. This grant program is part of our effort to promote drug take back as a safe way to dispose of unused prescription medication.

In order to participate, please contact your regional Area Agency on Aging, and they will collect the appropriate documentation and complete the reimbursement process. Our initial goal is to ensure a Take Back Box in every county, and we therefore ask that LEAs coordinate to that end.

Take Back Express (www.takebackexpress.com) is the preferred vendor for this grant. There are four receptacle options that fit within the reimbursement maximum of \$770 plus tax and meet the criteria for the grant.

The criteria are as follows: The unit should include a double- lock door, anchoring system or mechanism, be designed to prevent retrieval of the contents until removed by authorized personnel, and meet the requirements for a collection receptacle, under 21 C.F.R. § 1317.60 and § 1317.75, and any other standards set forth for these receptacles by the Drug Enforcement Administration (DEA).

Any LEA requesting reimbursement shall be responsible for any and all continuing costs for operation and maintenance of the receptacle, including, but not limited to, proper destruction of the collected medication.

Please consult with the DEA for any necessary clarification on procedures for such receptacles.
