situate, lying and being on Liberty Hill, an Eastern suburb
of the City of Columbia, in the County of Richland, South
Carolina, and being bounded as follows: North by lands of
estate of Malinda Thompson, now or formerly; East by lot
now or formerly of Building & Loan Association lot; South
by an alleyway and West by lot of Daniel Miles; said lot being
in shape a square and measuring 50 feet on all sides and being
the same lot conveyed to B. J. Pogue by Danie Miles by deed

dated May 4, 1903, and recorded in Deed Book "AH", page 438.

NOTE:1: It will be noted that the description in the last link does not conform to the description in the caption in that it refers to the lot as a square fifty feet on all sides. Physical land lines and descriptions of adjoining lots would indicate that the description in the caption is correct and the lot is longer on its Eastern and Western sides than on its Northern and Southern sides. The deed certainly should be taken with the description of the larger lot.

NOTE 2: The alleyway given as a Southern boundary of this lot came out of the property conveyed to Daniel Miles by Malinda Thompson. It is not included within this lot or the other lots adjacent to the alley and so title thereto would be in Daniel Miles, or his estate, if there had been no dedication of this strip as a public alley. That there was such a dedication, however, is, we believe, sufficiently established even without affidavits since the conveyances by Daniel Miles to this and adjoining land refer to the strip as a public alley. It is treated by subsequent grantees as a public alley. Several of the deeds in the chain of title of the lots adjacent to this alley refer to a plat of the property of Daniel Miles on which the property conveyed to him by Malinda Thompson was sub-divided into lots. It is probable that this plat establishes the strip as an alley, although the abstractor has not had access to that plat. The width of the alley is variously given as 10, 15 and 20 feet.

ENCUMBRANCES


We find no mortgages, judgments, lis pendens, mechanics liens, or other liens, on or affecting the title to the property herein abstracted.

TAXES

The property herein abstracted has been sold for past due State and County taxes and the deed made to the Forfeited Land Commission. It will therefore be necessary to have James R. Pogue, the present record owner, redeem the property from the Forfeited Land Commission and take a deed from the Commission before giving deed to the Columbia Housing Authority. According to the tax statement prepared by Miss Ellen I. Butler, Richland County Tax Collector, it will require \$105.57 to redeem the property from the Forfeited Land Commission. There are also unpaid city taxes in the amount of \$70.56, as shown by the statement hereto attached prepared by the City Sheriff.

OPINION

So far as the records and indices of Richland County show, in my opinion James R. Pogue has a good, fee simple, marketable title to the property herein abstracted, subject to the lien of the City of Columbia for city taxes and subject to his redeeming the property from the sale to the Forfeited Land Commission for State and County taxes, and taking a deed from the Commission.
