Yesterday, the MLKOG Board deliberated at length on the concerns raised by your staff since July 1 and outlined in the spreadsheet emailed to Margaret Plettinger Mitchell on August 10. We decided to accept your offer of a mutual agreement to discontinue Project FAITH. As difficult as this decision was, it seems to be the best method of acknowledging that both parties have responsibility in the difficulties experienced and have learned a lot from the process.

Please draft the necessary agreement to document this change in contract status that will be signed by both organizations. It is my understanding that this will be the documentation used to report to the Governor and Legislature on the outcomes of the Project FAITH portion of the Prevention Proviso.
