**Scott Fischbach** is the Executive Director of Minnesota Citizens Concerned for Life Global Outreach (MCCL GO), an outreach working to secure full human rights for all human beings. MCCL Global Outreach is a United Nations ECOSOC accredited Non-Governmental Organization. MCCL GO is also on the list of Civil Society Organizations registered with the Organization of American States. Additionally, Mr. Fischbach has been invited to contribute to the deliberations of the African Union regarding maternal mortality.



Mr. Fischbach developed MCCL Global Outreach eight years ago to extend the lifesaving work of Minnesota Citizens Concerned for Life internationally. Under his leadership, MCCL GO has been actively engaged in numerous international conferences and commissions. Written and oral contributions have been submitted to numerous meetings of the Conference on Population and Development, Conference on the Status of Women, Open Ended Working Group on Aging, Human Rights Council, Human Rights Committee and UNICEF Rights of the Child. Mr. Fischbach has attended and participated in the last seven WHO World Health Assemblies held each May in Geneva.

As the United Nations transitioned from the Millennium Development Goals to the Sustainable Development Goals, MCCL Global Outreach's counsel to delegates was to keep all development focused on the human individual, and in particular on the health and well-being of the individual in the first 1,000 days of life. Through myriad local, national and international consultations, Mr. Fischbach prioritized the importance of human beings, throughout the full life course, to remaining at the center of all sustainable development. Some of this language is now part of the preamble of the new SDGs approved by the U.N. General Assembly.

In addition to his international work, Mr. Fischbach has served in the John C. Stennis Institute of Government located at Mississippi State University. His role with the Institute has focused on overseeing two crucial research projects—one addressing the need for early childhood development and the other analyzing the post-Hurricane Katrina response of government agencies.

In his role as Executive Director of Minnesota Citizens Concerned for Life, Mr. Fischbach has fought hard to enact life-affirming legislation including the Positive Alternatives grant program that has now aided more than 50,000 pregnant women in Minnesota in choosing life. Positive Alternatives grants total \$20 million since 2007.

Working within campaigns and elections has always been a part of Mr. Fischbach's life. His own firm, Coalition Productions, Inc., was involved in national, state and local races, for which he developed support for candidates within various broad-based coalitions. Mr.

Fischbach was honored for his work as a “Rising Star in Politics” by Campaigns & Elections magazine.

Mr. Fischbach and his wife, State Senator Michelle Fischbach, who has previously served and is currently serving as President of the Minnesota Senate, participated in several Senate Presidents Forum events including seminars in Buenos Aires, Argentina, on United States-South American international trade, and in Venice, Italy, regarding economic challenges within the European Union.

Mr. Fischbach has traveled extensively and lectured on five continents including Europe, Asia, North and South America and Africa. Closer to home he has been an annual guest lecturer at St. Thomas University Law School in addition to lectures at Mississippi State University and the University of Minnesota Duluth.

Mr. and Ms. Fischbach have two grown children and three grandchildren and reside in Greater Minnesota. He attended Paynesville Area Schools, U.S. Capitol Page School in Washington, D.C., and graduated with a B.S. in Political Science and Speech Communications from St. Cloud State University.
