

Re: FOIA Request

Your three (3) Freedom of Information Act Requests were referred to this Office for a response. We checked with the three (3) areas of the Department that would normally have files of the type you mention in your request: The Contracts Division, the Division of Nursing Homes and Home Health and the Division of Long Term Care Reimbursement. The Department retains yearly cost reports on these types of facilities. However, we did not pull the cost reports for you. If you need them we will be happy to provide them, but you may want to specify the time period of interest.

Enclosed are copies of the Contracts and Nursing Home Division files on Carolina Health and Rehab, Inc. and Ridgeway Health & Rehabilitation Center, Inc. We could not locate a file on Heritage Healthcare of Ridgeway, LLC, nor could we tell that we had an enrolled provider by that name. Let us know if you have additional trade styles or operating names.

As you probably know, the South Carolina Department of Health and Environmental Control (DHEC) performs surveys and certifications of nursing homes. Our Contracts and Nursing Homes Divisions only gets and files so much of the DHEC survey forms as is necessary to perform their respective functions, so we often do not have complete copies of the documents. All files have been redacted of personally identifiable information on residents. Also, we avoid releasing provider numbers or tax identification numbers for reasons of business security.

Our expense for retrieving and copying this information is one hundred thirty-seven and forty-four hundredths dollars (\$137.44). Please make your check out to the agency and send it to:


