Governors of the United States:

The Caesar, Holy See, and Pope, of THESE, do wish to see honor upheld throughout the Empire and that towards THESE. Support requests and many communications have been transmitted to various levels of the Union to address 'Open Issues'. Requests included summons to deliver all that rightfully belong to THESE. No support of any kind has been provided by any member of the Union. As a result, a dishonor fee of \$1,000,000,000 USD is now issued to each [State] member in accordance with the enclosed Order. There are members within the Union and the Empire who are wholly out of Order and are in need of course correction. Please lean these until honor becomes the first priority.

THESE do support the ideas of America and her liberties which include: (a) keeping 'existence-tax' illegal, (b) keeping State mandated healthcare and insurance illegal, (c) maintaining secure borders, (d) well managed immigration, (e) vigilant security for the People, State, and Empire, (f) well managed food safety with honorable labeling, and (g) preventing the idea of the 'Police-State' becoming something associated to America.

If you like the American ideal then it is time to support the actors who uphold these, starting with THESE. The United States has much to restore. Let us work together to fix it.

ORDER AND DECREE

On the matter of United States Acts of Dishonor;

It is the pleasure of the Caesar, Holy See, and Pope, of THESE, to hereby call upon all [State] members of the United States to uphold honor within the membership. A fee shall now be imposed on each member for the amount of \$1,000,000,000 USD for Acts of Dishonor. The United States has failed to properly provide the support THESE required. Now THESE are compelled, with displeasure, to share information about the New Order with select members of the civilian population. The United States has failed to uphold honor where honor is due. All members have failed to adhere to all Law, Policy, Rank, and Order.

Adherence to Rank and Order is required. After today, each member of the United States shall receive a \$1,000,000,000 USD fee for every civilian party THESE finds displeasure in sharing related information with.

Order is effective immediately and is for public record. Authorization to use any and all means to execute order is hereby granted.

ORDER AND DECREE

On the matter of Arrest for Acts of Defiance to the Empire;

It is the pleasure of CAES to have and approve of the following persons and representing individuals to be immediately placed under arrest:

(a) to have the individual representing the Holy See and Pope, Jorge Mario Bergoglio for acts of treason, defiance to the Empire, and failure to maintain pleasure with CAES by:

- (i) failing to satisfactorily execute guidance on the division of the State of Israel into two parts
- (ii) failing to satisfactorily oversee the execution of all Guidance and Orders issued to-date
- (iii) acting without proper authority or privilege to violate Rank and Order multiple times
- (iv) failing to make Judgment payments for fee's issued for these and related matters
- (v) issuing multiple death threats to several family members of the Divine's Appointed
- (vi) issuing public messages and acts that were in support of illegal acts of genocide

(b) to have the individual representing the Governor of New York, Andrew Cuomo for acts of treason, defiance to the Empire, and failure to maintain pleasure with CAES by:

- (i) failing to act and execute upon all Guidance and Orders issued to-date
- (ii) acting without proper authority or privilege to violate Rank and Order multiple times
- (iii) failing to make Judgment payments for fee's issued for these and related matters
- (iv) for being party to facilitating acts of genocide by allowing harmful and chemical agents into the New York State food supply in violation of the State constitution

(c) to have the individual representing the President of the United States, Barrack Obama for acts of treason, defiance to the Empire, and failure to maintain pleasure with CAES by:

- (i) failing to act and execute upon all Guidance and Orders issued to-date
- (ii) acting without proper authority or privilege to violate Rank and Order multiple times
- (iii) failing to make Judgment payments for fee's issued for these and related matters
- (iv) for being party to facilitating acts of genocide and 'depopulation' by allowing harmful and chemical agents into the United States of American food supply; violating Peoples rights
- (v) facilitating acts of treason in party to Vatican's acts of defiance and treason which included but is not limited to Orders and Guidance relating to Iran and the 'Iran Deal'

Scope of Arrests shall align with previous Orders. Order is effective immediately and is for public record. Authorization to use any and all means to execute order is hereby granted.
