### Governor Nikki Haley News:

**Herald-Journal:** Company to invest \$2.5M in Cherokee County, create 77 jobs

A Missouri-based company that makes plumbing fixtures will invest \$2.5 million and create 77 new jobs in Cherokee County, S.C. Gov. Nikki Haley's office announced Wednesday. Sioux Chief Manufacturing will relocate its corporate headquarters and house its engineering, manufacturing and warehouse distribution operations in Chesnee at 815 Pickens St. The company plans to be fully operational this quarter and hiring for new positions has begun.

**Note:** "We're thrilled to see the impact this decision will have on the people of Cherokee, and look forward to seeing this fantastic company thrive here for many years to come," Haley said in a statement.

A bill to provide flood relief funds for farmers cleared the General Assembly this past week but faces a promised veto by Gov. Nikki Haley. A veto does not sit well with local farmers. "Why not sign the bill?" Orangeburg County farmer Edwin Smoak said. "I think that agriculture is something that needs all the support it can get. I sit down to a meal three times a day and that is because of agriculture." Smoak said though he will be able to survive another year through crop insurance, the full impact of last year's historic flooding may not be known for another four or five years.

**Note:** Haley has consistently stated she would veto the legislation, saying farmers shouldn't be treated differently than other flood-impacted businesses in South Carolina. The Republican governor reiterated Monday her veto will be based on fairness. "My heart breaks for farmers," Haley said. But "it would be wrong to bail out the farmers when we can't bail out small businesses, when we can't bail out homeowners."

A bill prohibiting South Carolina courts from enforcing foreign law in the state appears dead for this session. The Senate Judiciary Committee voted 10-9 on Wednesday against passing the bill, whose main purpose was to prevent Sharia Law from coming to the United States. Supporters say preventing judges from using laws based in Islam can protect America. Opponents say it solves a problem that doesn't exist because the state and U.S. constitutions assure no court can ever use foreign law.

The bill failed in the Senate Judiciary Committee with a 9-10 vote. "There's no need to talk about it, let's just do it," said Committee Chairman Larry Martin, R-Pickens, as the vote was being taken. Martin voted in favor of the legislation.

A bill that would have made the Muslim world's Sharia law an illegal defense in South Carolina courts was narrowly defeated in the state Senate on Wednesday, killing it for the year. The measure, sponsored by Charleston Republican Rep. Chip Limehouse, would have prevented an attorney from arguing that the laws of a client's home country allow for certain actions in South Carolina. "I'm not surprised," Limehouse said of the bill's failure to advance. "The Senate can be the graveyard of many good ideas."

Charleston's Sen. Marlon Kimpson vowed Wednesday to block every bill that seeks to expand access to firearms, shortly after placing a procedural hold on a proposal that seeks to prevent the state from enforcing federal gun laws that took effect this year. Kimpson, a Democrat, blocked advancement of the Second Amendment Preservation Act, a bill that breezed through the House of Representatives, in spite of the concerns of several House members.

A House-passed bill that would prohibit the enforcement of certain federal gun laws is headed to the Senate floor but its detractors could keep the legislation from being passed before next month's adjournment. A white former South Carolina police officer facing a state murder charge in the shooting death of unarmed black motorist Walter Scott will remain free on bail after his indictment on federal charges

During a hearing Wednesday in Charleston, a federal judge made the decision for Michael Slager, who was indicted this week on federal charges that also include obstruction of justice and unlawful use of a weapon during the commission of a crime. Slager, who is free on bail on state charges, will not have to put up any additional bond in the federal case. He entered a not-guilty plea during the federal hearing.

The dueling lawsuits over North Carolina's law on bathroom use by transgender people have landed in the hands of three federal judges appointed by Republican presidents. For more than a decade, doctors, dentists and nurse practitioners have liberally prescribed opioid painkillers despite mounting evidence that people were becoming addicted and overdosing on the powerful pain medications. Now, in the face of a drug overdose epidemic that killed more than 28,000 people in 2014, a handful of states are insisting that health professionals do a little research before they write another prescription for highly addictive drugs like Percocet, Vicodin and OxyContin.

Authorities in South Carolina say a barber with a history of aggressive behavior toward potential customers faces charges for pulling a gun on a man and telling him he "does not cut black hair." A York County Sheriff's Office report says when the man asked 65-year-old Larry Thomas what he meant, the man said Thomas grabbed a pistol and held it at his side. Public Information Officer Trent Faris said the incident report didn't indicate the victim's race. In one of eight similar instances dating back to 2007, Faris said Thomas, who is white, used pepper spray on a customer after getting into an argument. Thomas is jailed for pointing and presenting firearms at a person. His bond is \$3,000, and it's not known if he has an attorney.

Bernie Sanders has won his 19th state, only four short of Hillary Clinton's tally, but that's not the gap that counts. Despite his decisive victory in West Virginia on Tuesday, winning 51 percent of the vote to her 36 percent, Sanders trails nearly hopelessly in the contest for delegates needed to secure the Democratic presidential nomination. Clinton is in the mop-up phase now, 94 percent of the way to the magic number when the party insiders known as superdelegates are included, and on track to clinch the nomination in early June.

**Associated Press:** Future of Brazil's president on the line in key Senate

Brazil's Senate on Wednesday neared a historic vote on impeaching President Dilma Rousseff, likely ending 13 years of government by her leftist party amid a spate of crises besetting Latin America's largest nation. If a simple majority of the 81 senators votes in favor, Rousseff will be suspended from office and Vice President Michel Temer will take over for up to six months pending a decision on whether to remove her from office permanently. Senate President Renan Calheiros said he wants the vote to take place on Wednesday night and impeachment appeared to be foregone conclusion.

Three separate car bombings in the Iraqi capital Wednesday killed at least 93 people and wounded at least 165. The Islamic State group later claimed responsibility for all three bombings. But Wednesday's carnage demonstrates the group's lingering ability to launch significant attacks across the country and in the heart of the capital.
