M I N U T E S

Mr. Poore called the meeting to order and Mr. Wiles gave the invocation.

On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to approve the minutes of the June 1, 1979, meeting as mailed.

Mr. Dwight Mehaffy of Piedmont Engineers discussed the Solid Waste Recovery Study which his firm had been asked to do. Mr. Mehaffy asked that one member of Council and one member of the County staff be appointed to a committee to review the findings of the study. Supervisor Poore appointed Mr. Hooper and Mr. Clinton King to serve on the Committee.

Mr. Robert King discussed for approval a Flood Disaster Housing Plan. Mr. King stated that the plan designates two mobile home sites in the event of a large scale flood. Council received the study of the plan as information.

Mr. Poore introduced the 1979-80 Budget for second reading. Mr. Hehn read the Budget Ordinance. On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted three in favor with two against adopting Ordinance #35 on second reading. Mr. Gerrard, Mr. Hooper, and Mr. Rhodes voted in favor of the motion and Mr. Wiles and Mr. Wright voted in opposition to the motion.

Mr. Bob Lusk discussed an ordinance creating an Anderson-Oconee County Alcohol and Drug Abuse Commission. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt the ordinance on first reading.

Mr. Lusk introduced an ordinance creating the Anderson County Library Commission. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to adopt the ordinance on first reading.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to go into executive session at 9:50 a.m. to receive legal advice.

On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to reconvene at 10:37 a.m.

Mr. Lusk stated that Council had met with the Anderson County Reappraisal and Advisory Board concerning the requirements of Act 208. Mr. Lusk stated that no action had been taken by Council and that comments concerning the County Attorney and the Board had been received as information.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to adjourn at 10:40 a.m.
