I haven't looked at them prior to today, nor have I represented that we're against, but I would note the following:

4630 and 4629 represent substantial policy changes unwinding a grandfather agreement for certain licensed professionals. I would have put that on our office's radar prior to submission.

4628 seems to be permissive on its' face, but I would want to verify that. Put another way, we need to ensure that inclusion in scope of work for a licensed professionals doesn't exclude unlicensed professionals from doing those sorts of work.

4622 seems fine

4602 – I seem to remember some Joint Resolutions affecting the implementation of these codes, but that the state generally stopped at the 2012 versions – why are we seeing adoption of the 2015 codes?
