

To South Carolina Governor Nikki Haley,

About three years ago, I was arrested for carrying a concealed pistol, and the charge by the police was dismissed because black powder pistols are exempt from gun laws because they are to be considered antiques according to the good South Carolina state law, which agrees with the Bill of Rights.

Anyway, in court I mentioned to the state lawyer that the gun had a mind on it connected to a system that generally gets rid of possessors from the next world. They look like devils in the next world. This is true, and helps prevent crimes and accidents on Earth. As a result he told the judge I should be examined by psychiatrists at the local hospital. I mentioned to the lawyer when he suggested I be looked at by a psychiatrist, that I had the right to refuse. After the charge was dismissed by the judge after they looked up the law I told them about, I was put back in the Jail for a day more. Then I was called out of the cell, and put in a police car and driven to the local hospital where I was told the psychiatrist would interview me. I tried to tell the woman psychiatrist I was a religion founder and had read many books about the next world and other religions and philosophy, and she didn't give me time to also state that I had attended college at Rensselaer Polytechnic Institute in New York. She accused me of not listening to her and she wrote down something. Then they put me in a hospital room in a gown. I would later see the papers from the police, brought to me by a nice nurse, that I was committed under a suicide watch law. I suspect the lawyer and judge did not want me to refuse. So they committed me, and told the hospital staff I was crazy and had been carrying a gun around town.

The hospital staff knew nothing about the second amendment, freedom to bear arms. And I could not get a psychiatrist to agree with me on my right as a religion founder under the protection of the First amendment of the Bill of Rights, freedom of religion shall not be against the law. So I had a right to write anything, and tell anybody about the

next world and other religion matters. -This sometimes sounds crazy to those who have not read about it or thought about it themselves, but it is protected under the Bill of Rights. The Dillon County SC - McCloud Hospital psychiatrists and doctors and staff did not understand the Bill of Rights. Instead they gave me a shot of an unknown drug that hurt my special religion mind, which hurt my religion mind and many in the next world. The hospital rights brochure stated I had a right to refuse medication, which I did, so alot of men held me down so a nurse could inject it - which she was told she would go to a low plane (a hell) if she did, - but she went ahead and as a result she will be sad for a long time for hurting a religion. A few days later the police drove me at 85 mph down route 22 to Charlestown, over 150 miles at night with lights flashing, to the MUSC mental hospital. There the psychiatrists were similarly uneducated about religion and the Bill of Rights, giving me shots and thinking I was crazy. They wouldn't listen, so a few days later I pretended to be normal with no information about ghosts or other world things - then they were friendlier. Two weeks later I was taken to a judge, and all the judge did was believe the psychiatrist that I was mentally ill. The judge did not give me time to explain, and gave me two years of shots at the local Dillon Mental health clinic.

Psychiatrists make mistakes. They are uneducated about the Bill of Rights, and world religions and philosophy. Yet judges and many others believe them. There was no standard test for me to fill out or answer to determine my sanity, only the opinion of looking at me and talking a brief time with me. They need to do more research and be educated about more subjects to be accurate. Anyway my right to own a modern gun is now gone because I was mistakenly, and unlawfully put in a mental hospital. Present law stating that former mental hospital patients can not buy a gun. Could you please write and pass a new law, which some other states have, that psychiatrists can exempt someone who has been in a mental hospital, after passing an interview or test, so the determined to be mentally healthy, or wrongly charged individual, can go ahead and purchase modern guns at a gun store.
