Jonathan's Eagle Project is a Marian Prayer Garden on the grounds of the Stella Maris Catholic Church. Jonathan's project included installing several benches for prayer and meditation as well as landscaping and a statue that have greatly enhanced the beauty and contemplativeness of that part of the Stella Maris grounds. Hopefully this prayer garden will remain for years to come and will be a place for quiet contemplation by the parishioners and others.

For his Eagle Project, Danny worked through the National Park Service to identify areas of historic Fort Moultrie on Sullivan's Island where erosion was impacting the structure of the fort. Danny's project was to shore up several areas of the fort and install retaining walls to prevent continued erosion. Fort Moultrie is particularly significant for South Carolinians inasmuch as it is the site where Americans repelled a British invasion in 1776.

Simon's Eagle Project was to clear a very overgrown path on Sullivan's Island leading to the old bridgehead where the Pitt Street Bridge once connected Sullivan's Island to the mainland. Once he cleared the path, Simon installed a bench on the bridge head where there is a lovely view of the Intracoastal Waterway to be enjoyed by sightseers and fisherman alike.

All three boys have come up through scouting from the first grade, when they entered as Tiger Cubs and completed their Eagle Scout requirements just prior to their 18<sup>th</sup> birthdays.

Carlos da Costa is their current Scout Master and Carroll Joyner was their previous Scout Master. All three attended Boy Scout Camp each summer and many scouting activities throughout each year. Simon will graduate from Bishop England High School this year, and Danny and Jonathan are both completing their high school education as home schoolers. All three plan to attend college next year. All three boys are members of Stella Maris Catholic Church.

Danny's Eagle Court of Honor is scheduled for October 26, 2014.

Jonathan's Eagle Court of Honor is scheduled for November 23, 2014.


Simon's Court of Honor is also scheduled for October 26, 2014.
