Key Points

- Help is available to survivors in South Carolina, including disaster unemployment and legal assistance, and crisis counseling.
- Survivors in 24 South Carolina counties are eligible for Individual Assistance.
- Appeals to FEMA determination letters must be filed within 60 days of receipt. Specialists at the disaster recovery centers can help with appeals, or applicants can call the FEMA helpline: **800-621-3362** or **TTY 800-462-7585**.
- FEMA is looking for South Carolinians for full-time, temporary jobs.

Register for Assistance

- There are several ways to register.
- **Online:** www.DisasterAssistance.gov
- **By phone:** **800-621-3362** toll free from 7 a.m. to 10 p.m. daily. Multilingual operators available.
- Survivors who are deaf, hard of hearing or have a speech disability and use a TTY may call **800-462-7585**. Survivors who use 711 or Video Relay Service or require accommodations while visiting a center may call: **800-621-3362**.
- **In person:** For DRC locations, visit: <http://asd.fema.gov/inter/locator/home.htm>. Survivors may also speak with a Disaster Survivor Assistance team member in their communities. It is not necessary to visit a DRC.

Types of Assistance

- Grants can help pay for temporary housing; emergency home repairs; personal property losses; medical, dental and funeral expenses; other serious disaster-related expenses.
- SBA low-interest disaster recovery loans are available to eligible homeowners, renters and businesses of all sizes. (See P.4)
- Disaster Unemployment Assistance may be available to those who lost jobs or businesses. Apply at: <https://mybenefits.dew.sc.gov> or call: 866-831-1724. Deadline varies by county: Nov. 4 for Charleston, Dorchester, Georgetown, Horry, Lexington, Orangeburg, Richland and Williamsburg; Nov. 5 for Berkeley, Clarendon and Sumter; Nov. 6 for Calhoun, Darlington, Florence, Kershaw and Lee; Nov. 7 for Bamberg, Colleton and Greenwood; Nov. 12 for Newberry; Nov. 19 for Fairfield and Marion; and Nov. 26 for Greenville and Spartanburg.
- Legal assistance is available at no charge to survivors. Call: 877-797-2227 Ext. 120 or 803-576-3815 between 9 a.m. and 5 p.m., Monday through Friday.

- **Registrations**
 - **More than 70,000** individuals and households have contacted FEMA for assistance or

information.

- **Assistance**
 - Individuals and Households:
 - § **More than \$53 million** approved to help survivors with temporary rental assistance, essential home repairs and serious disaster-related needs.
 - **More than \$46.5 million of that amount** approved to help survivors find temporary rentals and make essential home repairs.
 - Other Needs Assistance:
 - § **\$6.4 million** approved.
- **Inspections**
 - **53,914** inspections completed.
- **Registration Deadline**
 - **Dec. 4, 2015**

Disaster Recovery Centers

- Visiting a DRC is not required for those seeking assistance, but staff can provide answers to questions about applications or appeals. Survivors may visit any DRC in the state.
 - Some DRC services include: status of applications; clarification of written correspondence; temporary rental assistance; and SBA loans.
- Free crisis counseling is available at some DRCs.
- DRCs are open **8 a.m. to 7 p.m. daily** at these locations, except when noted:

After Registering

- Survivors can expect a call from an Inspector.
- A booklet called “Help After a Disaster: Applicant’s Guide to the Individuals and Households Program” will answer many survivor questions.

Meeting with Survivors

- **Disaster Survivor Assistance Teams**
 - DSA teams are visiting neighborhoods in the storm-damaged counties.
 - DSA members wear blue FEMA shirts and have official FEMA photo ID.
- **Inspectors**
 - FEMA inspectors may contact survivors about their storm-damaged homes to schedule an inspection within seven to 10 days after an application is filed.
 - FEMA contract inspectors do not charge for this service.
 - Inspectors carry official FEMA photo ID and ask applicants to show proof of identity. Applicants should ask for ID from anyone claiming to represent FEMA.
 - Homeowners should identify all known damage and inform inspectors if the property has a septic system or well.
 - The average inspection takes 10 to 20 minutes.
- **Other contacts**
 - Others who may be in touch with survivors include insurance adjusters, local building inspectors, voluntary agency representatives and SBA specialists. No fees will be requested for any of these services.

Fraud

- Residents should report any suspicious activity or potential fraud.
- Ask to see credentials and contact local law enforcement if there is suspicion of an attempt to defraud. Do not pay in advance for services.

Donations

- Avoid charities soliciting door-to-door.
- The best way to donate help is to make a monetary contribution to one of the many Voluntary Organizations Active in Disaster.

U.S. Small Business Administration

- **Some \$22.9 million** in SBA loans approved.
- SBA’s Business Recovery Center is open to assist business owners in applying for low-interest disaster loans. Center locations and hours: Sumter County Civic Center, 700 W. Liberty St., Sumter

(Sumter County); Trident United Way Building, 6296 Rivers Ave., Suite 304, North Charleston (Charleston); Columbia Chamber of Commerce, 930 Richland St., Columbia (Richland); Conway Chamber of Commerce, 203 Main St., Conway (Horry). Hours: 9 a.m. to 5 p.m. weekdays.

- Survivors who believe they can't afford or won't qualify for an SBA loan should still apply as they may be eligible to receive other types of FEMA grants.

Insurance

- Insurance is a main source for money to put lives back in order after a disaster.
- Survivors should not wait for an insurance settlement before applying for a low-interest disaster loan from the SBA.

- The National Flood Insurance Program call center serves and supports policyholders. The phone number is **800-621-3362 (press 2 for NFIP)**. The hotline is staffed daily from 7 a.m. to 10 p.m.

Summary

- Twenty-four counties are designated for Individual Assistance: **Bamberg, Berkeley, Calhoun, Charleston, Clarendon, Colleton, Darlington, Dorchester, Fairfield, Florence, Georgetown, Greenville, Greenwood, Horry, Kershaw, Lee, Lexington, Marion Newberry, Orangeburg, Richland, Spartanburg, Sumter and Williamsburg.**
- Thirty-four counties are designated for Public Assistance: **Abbeville, Aiken, Allendale, Anderson, Bamberg, Beaufort, Berkeley, Calhoun, Charleston, Chesterfield, Clarendon, Colleton, Darlington, Dillon, Dorchester, Fairfield, Florence, Georgetown, Greenwood, Horry, Kershaw, Lancaster, Laurens, Lee, Lexington, Marion, Marlboro, McCormick, Newberry, Orangeburg, Richland, Saluda, Sumter and Williamsburg.**

ONLY IF ASKED:

- **D-SNAP:** The state Department of Social Services is offering temporary food assistance. Refer to the DSS website at <http://go.usa.gov/c3THB>, or call DSS at 800-616-1309.
- **Substantial damage** inspections and decisions occur at the local level based on local criteria and ordinances. Property owners with questions or concerns about substantial damage should direct their inquiries to their local officials.
