I'm writing the following in hopes to receive some kind of help. As it is well known on July 8th 2014 I was beat very badly during a riot. It was the Gangs Known as Bloods and Crips. I am currently on protective concerns here at the broad river correctional institution per orders of security, and state classification. I have been in a (SMU) unit since this happened at Lieber C.I in July, while all the inmates that did this to me along with a few other inmates are and have been in general population. In other words, I'm the one being punished for their actions. I did speak to a Investigator (Carter) at Lieber C.I and he took statements from myself, my roommate, a guy name named T.D. also the Institution has video cameras in Ashley unit and all that I state is true and on video. I was hit in the head with a homemade axe on the right side of my head/face, and received 6-stitches, then on my left temple and cheek that received 8-stitches, the back of my head with a pipe that had 6-staples, and my nose was crushed by a pipe and surgery was done on it. I was hit across my left forearm with the pipe, I was stabbed 4-times. 1-Time in my left Elbow, Twice in my left leg and once in my right leg. I was rushed to the Emergency Room for treatment, when my room-mate and I came back to Lieber C.I from the emergency room, we were placed in the the operating

holding cell and was told to go back to the same room and dorm that I was almost killed in. WE Both refused to go and was placed in separate holding cells in the (SMU) unit. I was placed in a holding cell for 2 days with no mattress, no water, no Toilet, only a concrete floor and my bloody cloths. no medical treatment and never offered to use the restroom. I urinated in a plastic tray. (SCDC) log books will show all this is TRUE. I asked Major Nettles (WNY) I was treated that way and he stated -(QUOTE) I'm not saying nothing about that, I'm leaving that alone. UNQUOTE and this was stated in front of investigator "Carter" and another Investigator that was from H.Q. ~~and~~ I was finally transferred after 90 days on (SMU) to Broad river C.I. Approximately 2 weeks later they sent the whole Ashby unit to Broadriver also, so my life is in danger again. I have wrote to Everyone in (SCDC) from the warden at Broadriver MR. R. STEVENSON to the Director of (SCDC) D. Sternin to be transferred to either Kirkland C.I or Perry C.I. were none of these gang members that was involved are at. I have to be put in a position to kill or be killed due to the neglect at (SCDC). NO I may not have known all the guys names that was involved but I no faces and nicknames and pointed them out and now I'm on lock-up with a couple of them. the others that was involved was on tape and pointed out by other victims and (SCDC) should of flagged me from all that was

I involved, not just the ones I picked out which (SCNC) hasn't even flagged them either. I requested State wide (P.C.) and was refused, I have asked to be shipped to another state - to do the remainder of my life. I have a substantial record, I could be transferred to any state under a security issue. I go to any yard other than Petty C.I or Kirkland C.I, I am going to have to face gang members over this very serious issue. I don't want to have to kill anyone and I don't want to die. But its wrong for me to have to be locked in a cell when [I] did NO WRONGS! I shouldn't have to live in fear of dying or having to kill another person. I have NO family at all and NO pending charges, Post convictions or any court proceedings pick a state to send me to, and I'll Go! my record is bad enough for a Emergency INTERSTATE COMPACT, so do it. Save a life or two. Again its not right or fair for me to have to live in fear of being killed or having to kill someone. like I've said, I've wrote everyone and NO ONE has responded to me. This is my last attempt before a civil law suit. I would appreciate your assistance in this very serious life and death matter, before state tort claims or civil actions are taken
