APPLICATION FOR EXTRADITION REQUISITION

NOW COMES J. STROM THURMOND, SOLICITOR FOR THE SECOND JUDICIAL CIRCUIT OF THE STATE OF SOUTH CAROLINA, AND CERTIFIES:

(A) That DANNY MAURICE TAYLOR is the name of the person for whom extradition is asked and that it is requested that Detective Chris Toole and/or Detective Chris Lind and/or his lawful designee(s) be designated to act as Agent for the State.

(B) That in the opinion of the undersigned the ends of public justice require that the fugitive named herein be brought to this State at public expense for trial.

(C) That the undersigned believes that he has sufficient evidence to secure the conviction of Danny Maurice Taylor

(D) That the person named as Agent herein is a proper person, and said Agent has no private interest in the arrest of said fugitive.

(E) That there has been no former application for requisition for the said fugitive growing out of this or any other transaction.

(F) That the accused is under criminal arrest in the State of North Carolina

(G) That this application is not made for the purpose of enforcing the collection of a debt, or for any private purpose whatsoever, and if the requisition herein applied for be granted, the criminal proceedings shall not be used for any of said objects.

(J) The fugitive is charged with Purse Snatching a violation of Section 16-13-0150 South Carolina Code of Laws, as detailed in the documents attached and has not been arrested in this State on this charge.

(K) Such Fugitive has fled from the justice of this State.

(L) Such Fugitive has taken refuge in the State of North Carolina

(M) Such Fugitive was present in this State at the time such crime was committed.

(N) Below is a brief statement of the circumstances of the crime committed by such Fugitive, and details of the subsequent breach of conditions of bail, bond, pardon, parole, probation, or failure to comply with the sentence of the court, or the circumstances of his escape if he did escape from confinement:

On February 17, 2016, while Connie Fulop was unlocking her car to put away the groceries in her cart, a black male with dreads exited the vehicle parked next to her and began talking to her. He then reached into her cart, which was also within her reach, and grabbed her purse out of the cart. He ran back to the vehicle he had exited, which was driven by a black female, and they quickly exited the parking lot. Ms. Fulop did not get a tag number. While law enforcement was patrolling the area, a call came in from a Kangaroo gas station that a black male with dreads just threw a black purse into a trash can. The caller did get the North Carolina tag number. The purse was retrieved and it did belong to Ms. Fulop. The gas station attendant said that the black female from that car used a SRP card belonging to Connie Fulop to put \$20 of gas into the vehicle. The NC tag was run and the vehicle was a rental and was rented to Danny Taylor. A tracking device on the vehicle was activated and it was located back in Goldsboro, NC, where Danny Taylor lives. A photo line-up was produced and shown to Ms. Fulop and she picked out the photo of Danny Taylor as the person who snatched her purse.




