Dear Mr. Tucker,

Thank you for your recent correspondence regarding the Second Amendment and your undeniable right to bear arms. Your engagement on this issue is an encouraging sign that citizens are taking a more active role in their government.

As a concealed weapons permit (CWP) holder myself, I fully support your right to protect yourself and your family in a safe and responsible way. South Carolina is a good neighbor in this respect as well, participating in permit reciprocity with 20 other states whose laws are compatible with our own. While I know South Carolina to be a firearm-friendly state, there are steps we can take to make exercising your right to bear arms more practical – steps like protecting the rights of employees to safely stow firearms in their vehicles when at work.

On June 29, 2012, I signed into law House Bill 4494, which allows for the purchase of rifles or shotguns in other states by South Carolina residents. Purchases must meet all federal requirements, but this law does maintain and protect your Second Amendment rights. I also signed Senate Bill 308 into law on February 11, 2014, expanding the list of places where a responsible concealed weapons permit holder can carry his or her firearm. These bills are small steps in efforts to promote your right to bear arms.

Again, thank you for your interest in South Carolina's firearm and concealed carry laws. As your governor, I will work to ensure that your Second Amendment rights are always secure. Please do not hesitate to contact me if I may be of assistance on this or any other issue.

In the wake of the Paris terrorist attacks, I had conversations with FBI Director Jim Comey and DHS Secretary Jeh Johnson. In the past, intelligence officials have had sufficient information to adequately check the backgrounds of refugee applicants. In reference to the Syrian refugees, neither Director Comey nor Secretary Johnson could vouch for the sufficiency of the available information. Therefore, I asked Secretary John Kerry and the United States Department of State to suspend efforts to resettle Syrian refugees in South Carolina.

As Governor, it is my first and primary duty to ensure the safety of the citizens of South Carolina. Dear Mr. Richard,

Thank you for your correspondence regarding my proposal that addresses the challenges our state faces when it comes to tax reform, state government restructuring, and state infrastructure funding.

Make no mistake, I believe taking care of our roads, bridges, and other infrastructure is a core function of government. We can and we should invest more dollars in transportation – that is something I have always supported.

But, we have to do a better job spending those dollars. We need a system that addresses our needs from a statewide perspective and doesn't prioritize roads based on which region, county, or city has the most influential legislator. And we should not raise taxes to do it. Not when we have \$1.3 billion in new revenue this year on the heels of \$1 billion in new revenue last year. We're overcharging you, the taxpayers – and I won't agree to charge you anymore.

So, as I have made clear to the General Assembly, I will not sign any piece of legislation that raises taxes – not in year one, not in year five, not in year ten. If the General Assembly passes legislation that cuts our taxes, reforms our flawed
