How States Handle the Transfer of Adult Offenders Across State Lines

According to the annual report from the Interstate Commission for Adult Offender Supervision, there were a total of 235,010 individuals on probation or parole who moved across state lines on compact supervision as of the close of fiscal year 2015. In 2014, a total of 60,948 cases were accepted for transfer while 23,696 cases were rejected--a rejection rate of 29.2 percent. States Sue Over New Overtime Rules

Twenty-one states are suing the U.S. Department of Labor, or DOL, over new overtime rules, which make it more likely states will have to pay more employees overtime. States involved in the suit are seeking an injunction that would prevent the new rules from going into effect on Dec. 1, 2016. On May 23, DOL issued final rules more than doubling the previous salary level test for white collar employees from \$455 per week, or \$23,660 per year, to \$913 per week, or \$47,476 per year.

interests of the West.


