An Italian company that makes roller bearings plans to open a plant in Colleton County, creating 50 jobs over the next five years. The state commerce department and Gov. Nikki Haley's office announced the new plant Wednesday. Production is expected to begin in September 2015.

An Italy-based maker of roller bearings plans to open its first U.S. manufacturing plant in Colleton County, creating 50 jobs over the next five years. Meter Bearings Group of Torino will open a 48,000-square-foot factory in Walterboro in a \$4.5 million investment, the governor's office and state Commerce Department announced Wednesday.

**Note:** Gov. Nikki Haley said it will provide "a real boost" to the rural area, and state Commerce officials hailed the announcement as another indication of foreign firms selecting the Palmetto State to set up shop.
