In your response, you requested additional certification as follows:

We have evaluated your request and recommended a plan of action to Budget and Control Board management and the Joint Legislative Committee on Governmental Accountability and Oversight. The Consolidated Procurement Code, which authorizes procurement certification reads, "The designated board office shall review the respective governmental body's internal procurement operation, shall certify in writing that it is consistent with the provisions of this code and the ensuing regulations, and recommend to the board those dollar limits for the respective governmental body's procurement not under term contract." [11-35-1210] In order to comply with the Code in processing your request, we are required to complete a review of your internal procurement operation prior to recommending your request.

Specific to the Department of Motor Vehicles we plan to initiate an audit of your procurement activities in February of 2009.
